Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Starting the Tractor	Incorrect starting procedure, Slips and falls	2M	<ul style="list-style-type: none"> - Conduct a pre-start safety check to ensure all controls and warning devices are functioning properly before starting the tractor. - Ensure the ground around the tractor is level and free of obstacles to prevent slips, trips, and falls when approaching or boarding the vehicle. - Familiarise yourself with the manufacturer's operation manual to understand the correct starting sequence for the specific model of tractor. - Wear non-slip footwear to provide adequate grip on steps and footplates when climbing onto the tractor. - Use the point of contact (both hands and one foot, or both feet and one hand) when mounting and dismounting the tractor to reduce the risk of falls. - Make sure no loose items and accessories such as lanyards are tucked away or removed to prevent entanglement with moving parts during tractor start-up. - Adjust the seat to ensure easy access to all controls without overreaching, which could cause loss of balance or control. - Ensure all safety guards and covers are in place and intact to prevent accidental contact with moving parts once the tractor is started. - Clear the area of bystanders before starting the engine to avoid endangering others with unexpected movements or noise from the machine. - Implement a lockout/tagout procedure to ensure maintenance staff are not at risk if they are servicing equipment linked to the tractor during startup. - Perform a horn and light check to affirm those systems are operational, enhancing visibility and audio alerts upon startup. - Educate operators on emergency shutoff procedures and location of the emergency stop button in case the tractor needs to be shut down quickly after starting. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
