Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, improper handling of tools	2M	<ul style="list-style-type: none"> - Conduct a pre-work safety briefing to inform all workers about potential hazards, focusing on slips, trips, and falls. - Ensure all work areas are clear of debris and obstructions by conducting a thorough inspection before starting any task. - Provide proper personal protective equipment (PPE) including non-slip boots, gloves, and eye protection, to all workers. - Use appropriate signage to alert workers to uneven surfaces or recently cleared areas that may be slippery. - Implement a clean-as-you-go policy ensuring tools and materials are stored in an organised manner throughout the job. - Conduct manual handling training to teach correct techniques for lifting, carrying, and using tools safely. - Ensure all tools are regularly maintained and checked for defects before use to prevent malfunctions during jobs. - Designate specific areas for tool storage and ensure they are easily accessible to prevent clutter and reduce hazards. - Use non-slip coverings or mats in areas identified as high-risk for slipping, especially if working outdoors. - Monitor weather conditions closely and reschedule work if environmental factors increase the risk of slips and falls. 	1L

Setting up Equipment	Electric shock, incorrect setting up of equipment	3H	<ul style="list-style-type: none"> - Conduct a risk assessment before setting up any equipment to identify potential hazards and implement appropriate controls. - Ensure all electrical equipment is tested and tagged according to Australian standards, with regular inspections to confirm compliance. - Use equipment that is designed specifically for the task and fits within the electrical safety guidelines relevant to edge trimming or edging jobs. - Provide comprehensive training for all personnel involved in setting up equipment, focussing on the use of Residual Current Devices (RCDs) to reduce the risk of electric shock. - Implement a lockout/tag-out system for all electrical equipment during setup to prevent accidental activation. - Regularly inspect power cords and extension leads for damage, ensuring they are free from cuts, abrasions, and exposed wires. - Maintain a clean and dry work area, using cord covers to prevent tripping or accidental cord damage during setup procedures. 	2M

Material Organisation	Heavy lifting, cuts from sharp materials		<ul style="list-style-type: none"> - Conduct a risk assessment prior to lifting any heavy materials to determine the safest method. - Use mechanical aids such as trolleys, forklifts or hoists to move heavy materials instead of manual handling. - Implement team lifting techniques where possible and ensure that adequate personnel are available for tasks requiring more than one person. - Provide training on safe lifting techniques, emphasizing correct posture and using legs rather than the back to lift items. - Ensure that all workers are wearing appropriate personal protective equipment (PPE), including gloves designed to resist cuts. - Regularly inspect PPE for wear and tear and replace any damaged items immediately. - Keep work areas clean and free from obstacles to prevent tripping and reduce the need to carry materials over long distances. - Clearly mark and store sharp materials separately in designated areas to minimize accidental contact. - Implement and enforce safe cutting practices, ensuring tools are properly maintained and suitable for the task. - Encourage a culture of reporting safety concerns promptly so that potential risks can be addressed quickly. - Limit repetitive lifting tasks by rotating job roles among workers to avoid strain-related injuries. - Ensure appropriate lighting in work areas to enable clear visibility for safe material organisation and handling activities. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
