Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Install Locks	Electrical hazards, falling objects, cuts from sharp objects	2M	<ul style="list-style-type: none"> - Conduct a pre-start safety meeting to discuss the task and potential hazards with all workers involved. - Ensure lock installation tools are in good working condition and regularly maintained to prevent malfunctioning. - Use insulated tools when working near electrical sources to reduce the risk of electric shock. - Verify that power to electrical circuits is switched off before commencing work to avoid accidental electrocution. - Wear appropriate personal protective equipment (PPE) including gloves and eye protection to guard against cuts and falling debris. - Secure ladders correctly using a 4:1 ratio for height and base, and ensure they are on stable ground to prevent falls. - Implement exclusion zones to keep unauthorised personnel away from the work area to minimise injuries from falling objects. - Use tool lanyards or tethering methods to secure tools at height and prevent them from falling onto people below. - Clearly label and isolate electrical sources before starting work to avoid inadvertent contact by other workers. - Regularly check the work environment for loose materials or debris that could potentially cause trips or falls. - Apply proper manual handling techniques when lifting heavy locks or equipment to prevent strains or back injuries. - Conduct regular site inspections to ensure compliance with WHS standards and address any emerging hazards. - Train all workers on the safe use of tools and emergency procedures specific to lock installations and electrical risks. - Have a first aid kit readily available on-site and ensure there is a trained first-aider present in case of cut or electrical injury. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
