If an incident or a near miss occurs, all work must sto, adately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Provide adequate training: All workers involved in excavation should be properly trained on safety procedures and use of equipment. Soil Testing: Determine the type of soil and its stability prior to excavation. This will dictate safe excavation practices and necessary precautions. Install protective systems: This could be in the form of benching, shoring or shielding, depending on the depth and type of soil in the excavated area. Use appropriate personal protective equipment (PPE): Hard hats, safety boots, gloves and high visibility clothing should be worn by all personnel on site. 	3H
