Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Unstable ground, Falling materials	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment, identifying any potential hazards and establishing appropriate control measures prior to commencing work. - A strict ground inspection should be carried out to ensure stability before digging. This includes testing soil composition and considering factors such as recent rainfall or natural erosion. - All personnel involved in the operation should be properly trained in safety procedures regarding excavation and trenching, including awareness of complications like falling materials. - There should be exclusion zones clearly marked around the site to ensure that only authorised personnel are permitted in the area. - Monitor weather conditions closely - cease operations if conditions become unsafe due to heavy rain or strong winds that may destabilise the ground or cause falling objects. - Use appropriate personal protective equipment (PPE). This includes items such as hard-hats to shield from potential falling materials, high visibility clothing, steel-capped boots for foot protection, and safety harnesses if necessary. - Always use the correct tools and equipment for excavation and trenching work. Shovels, spades and other equipment should be checked for their condition and suitability before beginning work each day. - Install supportive structures like shoring or trench boxes in unstable grounds to prevent the walls from collapsing. - Keep surplus excavated material at least 1 meter away from trench edges to avoid chances of falling materials into the trench. - Ensure there is appropriate emergency response procedures set in place on site in case of accidents. It should include first-aid facilities, trained first-aid personnel and availability of quick medical help. 	2M

Excavation planning	Lack of proper equipment, Inadequate skills	4A	<ul style="list-style-type: none"> - Conduct a pre-start workplace inspection: Identify the potential hazards around the excavation site like underground utilities, ground water, type of soil, walls etc. - Secure the right tools and equipment: Ensure all equipment being used is suitable for the tasks and is regularly inspected and maintained. - Provide adequate training: All workers involved in excavation should be properly trained on safety procedures and use of equipment. - Soil Testing: Determine the type of soil and its stability prior to excavation. This will dictate safe excavation practices and necessary precautions. - Install protective systems: This could be in the form of benching, shoring or shielding, depending on the depth and type of soil in the excavated area. - Use appropriate personal protective equipment (PPE): Hard hats, safety boots, gloves and high visibility clothing should be worn by all personnel on site. 	3H

			<ul style="list-style-type: none"> - Maintain safe access and egress: All excavation sites must have safe entry and exit points that are easily accessible in case of emergencies. - Regular safety briefings: Daily tool box talks should be held to remind all personnel of safety protocol on site. - Lighting arrangements: If work extends beyond daylight hours, appropriate lighting should be provided. - Implement Traffic management plan: If the work sites near a roadway, traffic controls may need to be put in place as part of the SWMS. - Regularly inspect excavation site: The site should be inspected by a competent person before start of each shift and after any occurrence which may affect the stability of the excavation. - Emergency response planning: An emergency response plan should be put into place, including immediate rescue and first aid measures. - Monitor weather conditions: Weather can greatly change working conditions. Halt all operations in extreme weather conditions to ensure safety.

Setting up site	Road traffic, Pedestrian movement	2M	<ul style="list-style-type: none"> - Ensure the work areas properly barricaded or fenced off to prevent unauthorised access. - Proper signage should be displayed both at the entry and exit points of the work site, which clearly indicates on-going excavation and trenching processes. - Check site regularly for potential hazards such as overhanging objects, unstable edges, changes in weather conditions and water ingress. - Implement road traffic management controls including using traffic controllers, flagmen, signs, cones, barriers and diversion routes where necessary. - Obtain proper work permits and ensure all employees are trained on safety guidelines involving pedestrians in the vicinity of the work site. - Ensure all workers wear reflective clothing so they can be easily seen by drivers and operators. - Provide training for those working on site about road and pedestrian safety. - Have a competent person inspect the job site at the start of each shift, following rainstorms, or after any hazard-producing occurrence. - Use guide ropes, long handle tools or other devices from outside the excavation to remove loose material from the sides of the excavation. - Use walkways with standard rails at all points where workers or equipment are required or permitted to cross over excavations. - Construct spoil piles, tools or other materials or equipment at least 2 feet back from the edge of the excavation, taking into account stress factors when determining the appropriate distance. - Set up vehicle exclusion zones and pedestrian exclusion zones around the areas where vehicles operate near the edge of an excavation. - Install or use pipe crossings above trench excavations for pedestrian and vehicle travel route. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
