Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

			- Utilize straps that match the specific type of load being secured to prevent accidents caused by incorrect choice of equipment. - Implement checklists to ensure all safety measures are followed before commencing work involving ratchet straps. - Include visual aids or demonstrations during training for better understanding of proper ratchet strap usage.

Positioning Straps	Caught in between loads and straps, Pinch points	3H	- Conduct a pre-task inspection to ensure straps and ratchets are in good working condition without any signs of fraying or damage. - Wear appropriate personal protective equipment, such as gloves and safety boots, to minimise risk of injury from pinch points. - Ensure work area is well-lit and free from obstructions to provide a clear view when positioning the straps. - Use a spotter to assist in guiding and monitoring the position of the straps around the load to prevent injuries from being caught between loads and straps. - Maintain clear communication between team members using hand signals or radios to coordinate movements and avoid unexpected strap tensioning. - Position your body to the side of loads when threading the straps to keep away from any sudden movement or shifting loads. - Keep hands and fingers away from potential pinch points, especially near the ratchet mechanism and strap loops. - Engage brakes on vehicles or equipment holding the load to ensure stability while positioning the straps. - Utilise tools such as load guards or edge protectors to prevent straps from slipping or being damaged during the fastening process. - Take regular breaks to reduce fatigue, which can increase the risk of accidental pinching or getting caught between objects. - Complete training for all workers involved in strapping procedures to ensure they understand safe practices and hazard awareness.	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
