### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

			<ul style="list-style-type: none"> <li>- Use Lockout/Tagout system during the maintenance or testing of fire suppression systems to ensure that no unexpected energisation occurs.</li> <li>- Only qualified and trained professionals should perform system inspections. Staff should understand the workings of the system, as well as the risks associated with inspection.</li> <li>- Regularly service the fire suppression system in line with manufacturer's recommendations to prevent equipment failures.</li> <li>- Have a rescue plan and first aid supplies readily available at the workplace. Ensure that workers have undergone first aid training.</li> <li>- Install safety signage and barriers around the work area to prevent unauthorised access and alert others about ongoing maintenance work.</li> <li>- Where possible, de-energise electrical equipment before starting system inspection. If this is not feasible, use appropriate insulated tools and take necessary precautions.</li> <li>- Conduct regular safety audits to detect potential hazards in advance and take corrective action promptly.</li> </ul> <p>Remember, a safe workplace is everyone's responsibility and it's important we all play our part in adhering to these control measures. Safety isn't just about protecting workers but it also ensures business continuity, productivity, and reputation management. With correct safety protocols in place, potential hazards can be identified and addressed promptly ensuring the well-being of everyone involved.</p>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
