If an incident or a near miss occurs, all work must sto, adately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Use mechanical aids such accolleys or hoists to conduct insport tyres whenever possible. Inspect all lifting and tregardly to ensure it is in good working order. Ensure that the work area is well-in and free constactes to reduce the risk of tripping while carrying tyres. Profunderson or control equipment (PPE) such as gloves with grips to improve handling and reduce the risk of lippage. Clear manuscafe line gizones and routes within the workplace to guide staff during manual handling tasks. Inductore-us schecks on all tools and equipment, ensuring they function correctly before use. Have a mergency response plan in place for incidents involving equipment failure. Implement a preventative maintenance schedule for all lifting equipment and inspect it according to mustracturer's guidelines. Train employees to recognise signs of equipment failure and report issues immediately. Limit the weight of tyres being manually lifted by one individual to within occupational health safety guidelines. Position tyres close to the side of trailers where they will be fitted, minimising carrying distance. Reassess risks regularly and revise control measures as necessary to incorporate new technology or insights from incident reports. 	1L

Provide and ensure the use of personal protective equipment (PPE), such as cut-resistant gloves and safety glasses, to protect against cuts and eye injury from sharp objects. Implement a regular cleaning schedule to keep the work area free of clutter, debris, and potential sharp hazards that may pose a risk during tyre inspection. Train workers on the correct ergonomic techniques for inspecting and handling tyres to minimise accidental contact with sharp or protruding elements. Use mechanical aids or lifting equipment to reposition or lift heavy tyre sections, reducing the chance of exposure to hidden sharp objects. 	1L

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
