Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Setting up counterweight system	Risks from moving heavy weight items, Falling from height		<ul style="list-style-type: none"> - Conduct a pre-start safety meeting to discuss the task and potential hazards with all team members. - Ensure all personnel involved in the task are trained in manual handling techniques to manage heavy items safely. - Use cranes or mechanical lifting devices operated by qualified personnel to move counterweight components, minimising manual lifting. - Establish exclusion zones with clear signage and barriers around work areas involving the movement of counterweights to prevent unauthorised entry. - Utilise appropriate personal protective equipment (PPE) such as gloves, steel-capped boots, and high-visibility clothing. - Implement a buddy system where workers can assist each other when moving or positioning heavy items. - Install guardrails or fall arrest systems at elevated positions where falls could occur, ensuring all employees use these systems correctly. - Perform regular equipment inspections to ensure that all lifting devices and safety gear are in proper working order before use. - Comply with safe work method statements (SWMS) for guidance on how tasks should be performed safely. - Assign a designated spotter to monitor all lifting operations and provide communications between crane operators and ground crew. - Arrange for regular breaks and rotate tasks among workers to prevent fatigue-related incidents during counterweight setup procedures. - Place anti-slip material on surfaces where workers walk or stand while handling counterweights to reduce the risk of slipping. - Engage with maintenance or engineering staff to confirm that the designed loads are within the equipment's operational limits. - Review emergency response procedures relevant to fall injuries or struck-by incidents with the entire team before beginning the task. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
