ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Equipment check	Injury from faulty equipment, Fires from leaky fuel systems	4A	<ul style="list-style-type: none"> - Conduct a thorough inspection of all equipment prior to use to ensure it is in good working condition. - Verify all tools and equipment are compliant with Australian Standards for safety and functionality. - Ensure that all fuel-handling equipment is compatible with the type of fuel in use to prevent chemical reactions or damage. - Implement a regular maintenance schedule for all equipment to address wear and tear before it leads to failure. - Equip all team members with appropriate personal protective equipment (PPE), such as gloves and goggles, when inspecting or handling equipment. - Use intrinsically safe tools that are specifically designed for fuel systems to reduce the risk of sparks. - Locate and secure an appropriate fire extinguisher nearby in case of fire emergencies during equipment checks. - Train workers on recognising the signs of equipment faults and instruct them to report any irregularities immediately. - Establish a clear communication protocol for reporting faulty equipment to supervisors without delay. - Store all equipment and tools in a dry, secure area when not in use to prevent environmental damage and contamination. - Post prominent signage near work areas warning of potential fire hazards due to leaky fuel systems. 	3H

- Ensure proper ventilation in the work area to minimise the concentration of any fumes associated with harmful fumes and physical injury.
- Use appropriate personal protective equipment such as respirators to prevent exposure to hazardous substances.
- Implement procedures for safe handling and storage of flammable substances to prevent explosion.
- Train employees on recognising symptoms of fume exposure and first aid measures in case an incident occurs.
- Limit the duration and frequency of exposure to potentially harmful fumes, and rotate tasks among workers.
- Install gas detection systems to monitor air quality and provide early warning of hazardous fume levels.
- Isolate the work area with barriers to prevent unauthorised personnel from entering, ensuring only trained personnel could be exposed to fumes.
- Ensure all tools and equipment are regularly maintained and inspected for leaks or malfunctions that could lead to fume exposure.
- Develop an emergency response plan outlining steps to take in case of a fume release, including evacuation procedures.
- Assign qualified personnel to supervise the work and ensure adherence to safety procedures.
- Provide ongoing training for staff on updated safety practices and how to identify and report leaks or fume incidents.
- Encourage reporting of near-misses and incidents to continually improve safety measures and prevent future occurrences.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
