Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Poor weather condition, Insufficient Personal Protective Equipment (PPE)	2M	<ul style="list-style-type: none"> <li>- Check the weather forecast prior to commencing work, and reschedule if severe weather conditions are predicted.</li> <li>- Conduct a site-specific risk assessment to identify any specific hazards related to the roof and its environment.</li> <li>- Ensure all workers have received proper training on working safely at heights and rooftop operations.</li> <li>- Provide suitable and sufficient PPE for all employees, including non-slip footwear, helmets, gloves, and high-visibility clothing.</li> <li>- Use fall protection systems such as guard rails, safety nets, or personal fall arrest systems, depending on the specific situation of the roof.</li> <li>- Implement an effective communication plan for all team members to ensure safety instructions are understood and followed.</li> <li>- Maintain an appropriate ratio of supervisors to workers to monitor safe work practices and compliance with procedures.</li> <li>- Establish an emergency plan specific to the site and ensure all team members are familiar with it, especially evacuation routes and first aid procedures.</li> <li>- Make sure that tools and equipment are checked and well-maintained, with regular inspections before use.</li> <li>- Install temporary edge protection where applicable, to prevent falls from unprotected edges of the roof.</li> <li>- Limit the number of workers on the roof during adverse weather to minimise risks.</li> <li>- Develop and practice contingency plans for sudden weather changes, like securing materials and moving to a safer location promptly.</li> <li>- Ensure clear access and egress points to and from the roof, keeping pathways free from obstructions.</li> </ul>	1L
2. **SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
