Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slips and trips, Electrical hazards	2M	<ul style="list-style-type: none"> <li>- Ensure the work area is clean and uncluttered before starting to minimise the risk of slips and trips.</li> <li>- Inspect all electrical equipment, including the floor stripper machine and extension cords, for any visible damage or wear before usage.</li> <li>- Utilise non-slip footwear appropriate for the task and wet working conditions, to provide better traction and prevent slipping.</li> <li>- Mark out the designated working area with temporary barriers, signage, or hazard tape to alert others and restrict unauthorised access.</li> <li>- Conduct a proper pre-start inspection of the work environment, identifying potential slip, trip, and electrical hazards that may arise during the floor stripping process.</li> <li>- Keep all electrical cords and wires clear of water or damp surfaces, using cord protectors, and never operating in standing water without taking proper precautions.</li> <li>- Provide adequate lighting around the work area, ensuring visibility of potential hazards is not compromised due to low lighting conditions.</li> <li>- Address any spills, debris, or loose materials as soon as they are identified to reduce the likelihood of slips and trips while using the floor stripper.</li> <li>- Ensure that power outlets used for electrical equipment have residual current devices (RCDs) installed to protect against potential electrical shock risks.</li> <li>- Use the appropriate Personal Protective Equipment (PPE), such as gloves and safety glasses, to protect yourself from various hazards associated with the floor stripping process.</li> <li>- Follow the manufacturer's guidelines and workplace procedures when operating the floor stripper, adhering to recommended safe working practices.</li> <li>- Keep all unnecessary personnel away from the work area while the floor stripping procedure is being conducted to minimise the risk of accidents or interference.</li> <li>- Regularly inspect equipment and initiate routine maintenance schedules to ensure its performance remains efficient and reduces the likelihood of breakdowns leading to potential electrical hazards.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- When possible, schedule equipment transport during less busy times of the day to minimise exposure to other workers or pedestrians.</li> <li>- Implement a buddy system where two or more workers can assist each other in moving heavy or awkward loads, helping to reduce the risk of manual handling injuries.</li> <li>- Wear appropriate personal protective equipment (PPE) such as steel-toed boots, gloves, and high-visibility vests to protect against potential injuries during movement of equipment.</li> <li>- Ensure that all workers are aware of emergency stop buttons or switches on equipment so they can quickly shut down machinery in a hazardous situation arises during transport.</li> <li>- Communicate and coordinate with other work teams in site to guarantee awareness and understanding of equipment movement timings and locations, reducing the risk of collisions.</li> <li>- Encourage open communication among team members by discussing tasks and seeking assistance when needed, helping them feel confident and empowered to work safely.</li> <li>- Regularly inspect and maintain mechanical aids (such as trolleys and hand trucks) to ensure their reliability, secure fitting, and readiness for use.</li> <li>- Designate a qualified and experienced worker to oversee the moving process and monitor equipment handling, ensuring adherence to safety protocols and identify potential concerns before they escalate.</li> <li>- Review and update the Safe Work Method Statement (SWMS) regularly to reflect any changes in equipment or work conditions, ensuring continued safety compliance and effective hazard control measures.</li> </ul>	
3. Setting up machine	Electric shock, Caught in moving parts	3H	<ul style="list-style-type: none"> <li>- Inspect electrical equipment: Before setting up the machine, ensure all electrical components, including cords and plugs, are in good condition to prevent electric shock.</li> <li>- Use appropriate personal protective equipment (PPE): Workers should wear appropriate PPE such as gloves, safety glasses, and closed-toe shoes to protect themselves from potential hazards when operating the floor stripper machine.</li> <li>- Check for power isolation: Ensure the area around the machine is clear of water and switch off any nearby electrical outlets to reduce the risk of an electrical hazard when setting up the machine.</li> <li>- Turn off the machine during setup: Make sure the floor stripper machine is switched off and unplugged while being set up to prevent any inadvertent activation and risk of caught-in incidents.</li> <li>- Keep hands and loose clothing away from moving parts: Workers should be reminded to keep their hands and loose clothing away from any moving parts of the machine while it is being set up to avoid getting caught or injured.</li> <li>- Proper training: All workers who are responsible for setting up the machine should be adequately trained and aware of the various risks associated with the process, allowing them to take appropriate precautions to minimise hazards.</li> <li>- Follow manufacturer's guidelines: Always adhere to the manufacturer's guidelines and recommendations when setting up the machine, as they are designed to mitigate potential hazards and ensure safe operation.</li> </ul>	1L

		<p>Make sure that there are no problems or issues that might affect the setup process.</p> <ul style="list-style-type: none"> <li>- Set up in a well-lit and ventilated area: Ensure the workspace is well-lit and ventilated to reduce the risk of accidents during the setup process.</li> <li>- Establish an exclusion zone: Set up a clearly marked exclusion zone around the equipment so that only authorised personnel can access the area. This will help control access to the machine and other hazards associated with setting up the equipment.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
