Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Pre-operational inspection	Ignoring evident faults, Failure to report defects	3H	<ul style="list-style-type: none"> - Conduct thorough visual inspections of the forklift before each shift, checking for any visible damage or wear on tyres, forks, mast, and overhead guards. - Ensure all operators are trained and competent in pre-operational inspection procedures specific to the forklifts they will be using. - Use a comprehensive checklist that includes all critical components such as brakes, steering, lights, warning devices, controls, and fluid levels. - Implement a system for immediate reporting of any defects or faults identified during inspections to supervisors or maintenance personnel. - Establish a routine maintenance schedule based on manufacturer recommendations and ensure it's followed meticulously. - Clearly document all inspections, including any faults found and the actions taken to address them, and maintain records according to company policy. - Provide operators with personal protective equipment like gloves and safety glasses when conducting inspections, especially if handling hazardous materials is involved. - Install signage near storage areas reminding operators to conduct pre-operational checks before using the forklift. 	2M

Forklift positioning	Tipping over due to misguided manoeuvre, Collision with other vehicles or structures	3H	<ul style="list-style-type: none"> - Ensure the forklift operator is trained and holds a current licence specific to the forklift type being used. - Conduct a visual check of the work area to identify and remove any obstacles or hazards that could affect safe manoeuvring and positioning of the forklift. - Establish and maintain clear visibility of the path in which the forklift will operate, ensuring adequate lighting and removal of blind spots where possible. - Implement and adhere to a designated speed limit within the operating area to allow for safe stopping and turning of the forklift. - Use a spotter when visibility is limited or obstructions are present to guide the operator, ensuring safe movement and positioning of the forklift. - Maintain a safe operating distance from other vehicles, structures, and pedestrians, using signage or barriers as necessary to delineate safe zones. - Regularly inspect the forklift's steering, brakes, and tyre conditions to ensure optimal performance and reduce the risk of tipping due to mechanical failure. - Utilise suitable attachments and secure loads properly to prevent load shift during transportation, which could destabilise the forklift. - Engage stability control systems if available on the forklift model to automatically correct or alert unsafe conditions that may lead to a tip-over. - Develop and communicate a traffic management plan that includes guidelines for interactions between forklifts and other site vehicles to avoid collisions. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
