Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trips and falls, Manual handling injuries	2M	<ul style="list-style-type: none"> - Implement a site-specific induction and training programme for all workers, addressing potential hazards associated with the formwork construction process, including trips, falls, and manual handling injuries. - Develop and maintain a clean and organised work area to minimise clutter, which can lead to trips and falls. - Clearly mark pathways and provide adequate lighting in the work area to prevent tripping accidents. - Provide proper Personal Protective Equipment (PPE), such as non-slip footwear to all workers involved in formwork construction. - Ensure correct lifting techniques are used by providing necessary training and supervision on safe manual handling practices. - Use mechanical aids or equipment, such as trolleys or cranes, to move heavy objects and materials wherever possible. - Encourage workers to seek assistance when lifting heavy objects, working as a team to reduce the risk of injury from manual handling tasks. - Schedule regular breaks for workers engaged in physically demanding tasks to help prevent fatigue-related issues. - Encourage open communication between workers, supervisors, and management to identify and address any potential hazards as they arise in the preparation phase. - Regularly inspect the work area for potential hazards and proactively address any identified issues, such as uneven surfaces or obstructions in walkways. - Implement a system to promptly report incidents and near misses related to trips, falls, and manual handling injuries, and use this information to continually improve safety measures. - Carry out a thorough risk assessment before commencing any formwork preparation tasks, taking into account site conditions, worker experience, and available resources. - Constantly review and update the Safe Work Method Statement (SWMS) for formwork preparation tasks as new risks or control measures are identified throughout the project. - Engage experienced and qualified staff for supervisory and management roles to ensure effective implementation and oversight of control measures during the formwork preparation process. 	1L

Site inspection	Falling objects, Uneven ground	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection before commencing formwork activities, identifying any hazards such as uneven ground or potential for falling objects. - Designate a drop zone around the work area and mark it with clear signage to alert workers of potential falling object hazards. Make sure all workers are aware of these areas and avoid entering them without proper PPE. - Ensure that all overhead work is performed by properly trained personnel using appropriate equipment, such as fall protection systems, harnesses, tie-off points, and barriers. 	2M

			<ul style="list-style-type: none"> - Regularly inspect, maintain and repair all formwork components to minimise the risk of failure that can cause materials or tools to fall. - Utilise temporary barricades or guardrails around elevated work areas to prevent workers from accidentally dislodging tools, materials or debris into lower levels. - Install netting or other containment systems below elevated work areas to catch falling objects and minimise damage or injury should an incident occur. - Use secured toolboxes, storage containers and hoist systems for carrying or storing tools and materials at height, reducing the risk of accidental drops. - Level out uneven ground surfaces within the designated work area to create a stable working platform for formwork construction. This may involve soil compaction, importing fill material, or even installing temporary ramps as needed. - Provide workers with appropriate footwear for navigating uneven terrain, such as non-slip boots or rubber-soled shoes, to reduce the risk of slips and trips. - Encourage workers to maintain situational awareness and take extra precautions when walking or operating equipment near uneven ground or elevated workspaces, including regular communication between team members about identified hazards and ongoing mitigation efforts.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
