Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Gas cutting setup	Gas leaks, Fire hazards	3H	<ul style="list-style-type: none"> - Regular inspection and maintenance of equipment: Ensure that all gas cutting equipment, including hoses, regulators, torches, and cylinders, are inspected regularly for any signs of damage or wear. Any faulty equipment must be repaired or replaced immediately to prevent gas leaks and fire hazards. - Proper storage of gas cylinders: Store gas cylinders in a well-ventilated area away from sources of heat and ignition. Keep cylinders secure and upright to prevent them from falling and causing gas leaks. - Use of flash arrestors: Install flash arrestors on the torch and the regulator to prevent reverse flow of gases and flashback, reducing the risk of fire hazards. - Leak testing: Before starting the gas cutting process, perform a leak test by applying a soapy water solution to all connections within the system. If bubbles form, it indicates a leak that must be fixed before proceeding with the cutting. - Trained personnel: Ensure that only trained and competent operators use the gas cutting equipment. They must be familiar with proper setup procedures and safety precautions to minimise risks associated with gas leaks and fire hazards. - Safe work environment: Clear the area around the cutting operation of any flammable or combustible materials, and ensure appropriate ventilation to dissipate fumes and gases from the cutting process. - Fire extinguisher availability: Have an appropriate type of fire extinguisher readily available near the gas cutting area in case of emergencies involving fire hazards. 	1L

			<p>- Personal protective equipment (PPE): Provide workers with suitable PPE, such as flame-resistant clothing, gloves, safety goggles, and welding helmets. This reduces the risk of injury due to exposure to flames, sparks, and hot metal pieces generated during the gas cutting process.</p> <p>- Emergency plans: Develop and communicate emergency response plans, including actions to take in case of a gas leak or fire. Regularly train employees to ensure they are familiar with the plans and can respond swiftly and effectively in an emergency situation.</p> <p>- Proper shutdown procedures: Instruct workers on the proper steps to follow when shutting down equipment after the gas cutting process, including closing cylinder valves, releasing gas from hoses, and properly storing equipment. SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
