ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation | Trip hazards, Falling objects | 2M | <ul style="list-style-type: none"> - Conduct a thorough risk assessment of the worksite prior to commencing gas installation, identifying all potential hazards, including trip hazards and falling objects. - Implement proper housekeeping measures throughout the work area, regularly clearing away any rubbish, debris, or loose materials that could cause tripping or falls. - Utilise high-visibility tape, cones, or other signage to clearly demarcate areas where trip hazards are present or where falling objects may be a concern. - Establish designated walkways with clear markings within the worksite to minimise exposure to trip hazards and possibility of falling objects. - Store all heavy or bulky materials securely on shelves or in designated storage areas to prevent them from becoming trip hazards or falling objects. - Regularly inspect and maintain all equipment used for gas installation, ensuring that it is in good working condition and properly secured when not in use. - Provide adequate training to all staff involved in the gas installation process, including specific training on recognising potential hazards and implementing appropriate control measures. - Encourage open communication among team members, fostering a culture of reporting any identified hazards or near misses immediately to supervisors or management for appropriate action. - Develop an emergency response plan that outlines predetermined procedures to follow in the event of a trip hazard or falling object incident at the worksite. - Equip all employees with appropriate personal protective equipment (PPE), such as slip-resistant footwear and hardhats, to minimise the risks associated with trip hazards and falling objects. - Monitor weather conditions before and during the gas installation process, postponing or altering work activities if high winds or other adverse conditions create an increased risk of falling objects. - Employ engineering controls, such as toe boards, guardrails, or netting systems, to prevent tools and materials from accidentally falling from elevated work areas. - Conduct regular toolbox talks and safety briefings to reinforce safe work practices relating to trip hazards and falling objects, incorporating any lessons learned from previous incidents or near misses in the industry. | 1L |

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
