Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

This could include items like safety boots, gloves, eye protection, and dust masks as appropriate.</li> <li>- Safe substance handling: Unsafe handling of hazardous substances can lead to accidental spills and exposures. Training and supervision in correct handling techniques are essential.</li> <li>- Regular risk assessment: Frequent workplace inspections help identify potential hazards early on. Swift corrective action can prevent slips, trips, falls, and exposure to hazardous substances.</li> <li>- Clear signage: Putting up proper markings and warning signs to indicate areas where there is a risk of slipping, tripping, falling, or exposure to hazardous substances.</li> <li>- Maintenance of equipment/tools: Over-used or poorly maintained tools and equipment can make your workplace more dangerous. Make it a routine to inspect tools and equipment for wear and tear and service them regularly.</li> <li>- Safety training: Employees should undergo appropriate safety training on handling hazardous substances and working in potentially risky environments.</li> <li>- Emergency response plan: These types of emergencies require a quick response. Having plans and drills for dealing with such incidents will minimise potential damage and injuries.</li> <li>- Barrier installation: Temporary physical barriers to segregate the grapple truck operation area from other workers. Barriers and warning signs can also be used for demarcating hazardous substances storage areas.</li> </ul>	1L
2. 			<ul style="list-style-type: none"> <li>- Use flaggers or spotters when positioning the truck at the work site.</li> <li>- Keep pedestrians informed of ongoing operations and discourage any entry into the operation zone.</li> <li>- The grapple truck should be equipped with reversing beepers and lights to alert people of its movements.</li> <li>- Check for any overhead or ground-level obstacles upon arrival at the site.</li> <li>- Continually monitor weather conditions, as they can affect ground condition and visibility.</li> </ul>

Unload Equipment	Manual handling injuries, noise exposure	3H	<ul style="list-style-type: none"> <li>- Ensure workers are trained in the safe use of grapple trucks and related equipment.</li> <li>- Provide staff with personal protective equipment (PPE) such as earmuffs to limit noise exposure.</li> <li>- Define clear drop zones for unloading materials to minimise risk of injuries.</li> <li>- Prohibit unnecessary manual handling, using mechanical aids wherever possible.</li> <li>- Ensure hydraulic devices, like the grapple hook, are tested and maintained regularly to reduce the chance of sudden breakdowns.</li> <li>- Conduct regular toolbox talks on safety measures and procedures for unloading operations.</li> <li>- Limit repetitive motions that could lead to musculoskeletal disorders; recommend rotation of tasks among workers.</li> <li>- Use tag-out/lock-out procedures when performing any maintenance or inspections on the truck.</li> <li>- Establish a communication system, like hand signals or radios, amongst workers during unloading operations to promote effective coordination and ensure safety.</li> <li>- Implement stringent traffic management plans around unloading areas.</li> <li>- Encourage fatigue management strategies including appropriate rest breaks during long haul routes.</li> <li>- Ensure appropriate risk assessments are conducted prior to each work step and findings communicated to workers.</li> <li>- Foster a safety culture in the workplace where incidents can be reported without fear of reprisal.</li> <li>- Perform regular audits and reviews on health and safety processes to identify any gaps in safety procedures or practices.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
