Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Grate Selection	Incorrect size or type causing falls, Weight of grate causing injury	3H	<ul style="list-style-type: none"> - Conduct a thorough site assessment to determine the appropriate size and type of grate required for each specific location. - Use manufacturer guidelines and specifications to select grates that meet or exceed safety standards and are suitable for the intended load-bearing requirements. - Ensure all personnel involved in the selection process are trained in understanding grading specifications and compliance requirements. - Double-check measurements and seek a second opinion from a supervisor or experienced team member before finalising the grate selection. - Maintain a checklist of criteria for grate selection to minimise the risk of errors during the decision-making process. - Use colour-coded tags or labels on grates to easily identify the correct size and type, reducing the chance of installing an incorrect grate. - Implement a standardised communication protocol within the team for verifying and confirming the selected grate prior to installation. - Utilise lifting equipment such as cranes or hoists to move heavy grates, ensuring workers avoid manual handling where possible. - Provide training and issue reminders on proper manual handling techniques when lifting is unavoidable, focusing on teamwork and using aids. - Introduce a buddy system so workers can assist each other, especially when manoeuvring large or awkward-sized grates. 	2M

Unloading grates	Injury from heavy lifting, Crash injuries	4H	<ul style="list-style-type: none"> - Ensure all personnel involved in unloading are adequately trained in manual handling techniques to minimise the risk of injury from heavy lifting. - Use mechanical aids such as forklifts or pallet jacks whenever possible to reduce the need for manual lifting of heavy grates. - Conduct a site inspection beforehand to identify any potential hazards and ensure a safe unloading area. - Implement clear communication protocols among team members during the unloading process to coordinate movements effectively and avoid accidents. - Use appropriate personal protective equipment (PPE) such as gloves and steel-toed boots to protect against injuries from dropped grates or unexpected movements. - Establish exclusion zones around the unloading area to keep non-essential personnel at a safe distance. - Apply correct loading techniques, keeping loads close to the body and avoiding twisting or bending at the waist. - Plan the unloading sequence to prevent stacking of grates too high, which could lead to tipping and crash injuries. - Inspect all equipment, including forklifts and pallet jacks, before use to ensure they are in safe working order. - Utilize tag lines or guide ropes for stability when unloading grates from vehicles, especially in windy conditions. - Ensure the vehicle is parked on stable, level ground with the brakes engaged to prevent movement during unloading. - Rotate tasks among workers to distribute physical workload evenly and minimize strain-related injuries. - Keep walkways and unloading areas clear of obstructions to ensure free movement and reduce trip hazards. - Review emergency procedures with the entire team prior to starting work, ensuring quick response capability in the event of an incident. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
