Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Exposure to harmful dust, Equipment malfunction	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify potential sources of harmful dust and equipment malfunction. - Use appropriate personal protective equipment (PPE), including respirators, eye protection, and protective clothing, to minimise exposure to harmful dust. - Ensure all grit blasting equipment is maintained and in good working order through regular inspections and preventative maintenance. - Implement adequate ventilation systems or use dust extraction equipment to reduce airborne dust levels in the work area. - Establish exclusion zones around the grit blasting area to protect other workers from exposure to dust and any potential equipment failures. - Provide thorough training for all workers involved in the operation on the safe use and handling of blasting equipment and materials. - Regularly monitor air quality within the work area to ensure dust concentrations remain below occupational exposure limits. - Develop and enforce a schedule for regular breaks for workers to prevent fatigue, which could lead to equipment mishandling. - Implement procedures for the immediate reporting and repair of any equipment malfunctions to prevent further hazards. - Use alternative materials with lower dust production where feasible to reduce the overall dust hazard. - Develop an emergency response plan specifically addressing incidents involving excessive dust release or equipment failure. 	2M
2. Grit selection	Incorrect grit size selection, Slip and trip hazards	3H	<ul style="list-style-type: none"> - Select grit size according to the surface type and desired finish based on manufacturer's guidelines. - Consult Safety Data Sheets for each type of grit to ensure appropriate use and handling procedures. - Provide training for workers on selecting correct grit size for specific surfaces and conditions. - Label containers of different grit types clearly to avoid confusion and incorrect selection. - Establish guidelines for operators on changes in grit type or size depending on varying work surfaces. - Conduct routine checks by supervisors to confirm correct grit is being used as per job requirements. - Store grit in a dry, well-organised area to prevent spills and contamination with other materials. - Introduce regular inspection schedules to identify signs of wear or damage to grit storage containers. - Implement housekeeping procedures to keep the workspace clean and free from spillages. - Ensure appropriate personal protective equipment (PPE) such as non-slip boots are worn by all workers to prevent slips and trips. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
