ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Backfilling	Working around heavy equipment, ground instability	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to communicate roles, responsibilities, and the backfilling plan to all workers. - Maintain safe distances between workers and heavy equipment at all times by establishing exclusion zones. - Use spotters to guide heavy machinery and ensure clear communication protocols are in place. - Inspect ground conditions regularly for signs of instability or unforeseen hazards such as hidden voids or soft spots. - Implement traffic management plans to control vehicle movement and minimise risk in the work area. - Ensure that operators of heavy equipment are certified and experienced in backfilling operations. - Post warning signs and barriers around unstable areas to prevent accidental access. - Use appropriate personal protective equipment (PPE), including high-visibility clothing and head protection for all personnel on site. - Limit the height and slope of soil piles to prevent collapse during backfilling. - Have an emergency response plan in place, including first aid and evacuation procedures, in case of an incident. 	2M

Compaction	Noise exposure, vibration exposure	2M	<ul style="list-style-type: none"> - Use hearing protection such as earplugs or earmuffs to reduce noise exposure. - Implement a job rotation schedule to limit the time an individual is exposed to excessive noise and vibration. - Ensure machinery and equipment are regularly maintained and serviced to minimise noise levels. - Utilise vibration-reducing accessories or anti-vibration gloves for workers handling vibrating tools or equipment. - Set up exclusion zones to keep non-essential personnel away from areas with high noise levels. - Conduct regular noise monitoring assessments to ensure compliance with permissible exposure limits. - Provide training for workers on the risks of noise and vibration exposure and how to use protective equipment properly. - Install noise barriers or soundproof panels around machines that produce high noise levels, where feasible. - Limit the operation of heavy machinery to times when fewer site personnel are present to reduce collective noise exposure. - Process and approve a risk assessment and safe work method statement specifically targeting noise and vibration hazards before commencing the activity. 	1L

Surface Restoration	Improper surface restoration, re-occurrence of excavation hazards	2M	<ul style="list-style-type: none"> - Conduct a thorough inspection of the excavation site to ensure all hazards have been identified and addressed before restoration begins. - Use appropriate materials for backfilling, ensuring they match the original soil type or meet structural requirements. - Compact the backfill in layers to avoid settling, using suitable equipment and techniques for the material and depth. - Clearly mark and document all underground services that were disturbed or discovered during excavation for future reference. - Engage qualified personnel to oversee the restoration process, ensuring adherence to relevant safety standards and regulations. - Implement erosion control measures such as silt fences or grass seeding on slopes, preventing washout or erosion post-restoration. - Verify that water drainage patterns are restored to pre-excavation conditions to prevent water accumulation or flooding. - Use barricades and signage to restrict access to the freshly restored area until it is stable and deemed safe for regular use. - Educate workers on correct procedures and the rationale behind each step involved in surface restoration for improved compliance and awareness. - Obtain necessary permits and approvals from local authorities before commencing surface restoration, especially if changes to the original landscape are involved. - Record all activities undertaken during the surface restoration process, maintaining detailed logs for accountability and future audits. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
