Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip hazards, Electrical hazards	3H	<ul style="list-style-type: none"> - Conduct a site inspection to identify potential trip hazards such as uneven surfaces or loose materials and clear the area before beginning work. - Mark and barricade off the work area with appropriate signage to warn employees and visitors of potential hazards. - Use cable covers or tape to secure any electrical leads running through the work area to prevent tripping. - Ensure all employees are wearing appropriate personal protective equipment (PPE), including high-visibility clothing and safety boots, to minimise injury risks. - Keep the work area organised and free from clutter by regularly clearing away tools, equipment, and debris to maintain a safe environment. - Label all electrical cables, outlets, and appliances in use and conduct a visual check for any damage or wear prior to use. - Implement a system to regularly check and tag all electrical tools and appliances with current test and tag certifications to ensure they are safe for use. - Provide training to workers on how to recognise and respond to electrical hazards, including emergency procedures for incidents involving electricity. - Limit the number of workers operating in the immediate work area to reduce crowding and the potential for trips and falls. - Install adequate lighting in the workspace to ensure proper visibility, particularly in areas prone to shadows or poor natural light. - Establish a procedure for reporting and promptly addressing any identified trip or electrical hazards during the course of work. - Use non-slip mats or slip-resistant coatings on floors where water or other substances might increase the risk of slipping. - Schedule regular breaks for workers to reduce fatigue-related accidents that can lead to increased likelihood of trips or missteps. 	2M

Setting Up	Crushing hazards, Fall from height	4A	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss the specifics of the site layout and potential hazards with all team members. - Use mechanical lifting aids or equipment like cranes or hoists to position heavy guardrail materials to minimise manual handling and reduce crushing risks. - Ensure all workers are wearing personal protective equipment (PPE), including helmets, gloves, and safety boots, designed for working at heights and around heavy equipment. - Erect temporary edge protection, such as temporary guardrails or scaffolding, while setting up permanent structures to prevent falls. - Implement a designated exclusion zone around the installation area to keep unauthorised personnel clear during lifting and placement activities. - Utilise certified and inspected equipment with secure anchor points for fall arrest systems where work is performed near open edges. - Position spotters or use safety signage to guide machinery operators when moving materials to prevent collision with other workers. - Inspect the worksite prior to starting to identify any unstable surfaces or uneven ground that can pose a risk during setup, taking corrective action as required. - Provide training on emergency procedures in case of an incident, ensuring quick response capability if someone is injured or a fall occurs. - Review and follow manufacturers' guidelines for guardrail installations to ensure all components are correctly and securely assembled. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
