Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Manual handling, Unsecured work area	2M	<ul style="list-style-type: none"> - Conduct a risk assessment prior to beginning the task to identify potential hazards and appropriate controls. - Provide training for all workers on safe manual handling techniques specific to glass materials. - Use appropriate personal protective equipment (PPE) such as heavy-duty gloves, safety glasses, and long sleeves or protective clothing. - Ensure the workers are well-lit to enhance visibility when identifying and handling broken glass. - Mark and secure the work area using physical barriers or caution tape to prevent unauthorised access. - Maintain a clean and organised work area by regularly clearing away debris and waste materials. - Utilise mechanical aids like trolleys or carts to transport broken glass whenever possible. - Limit manual lifting by breaking down larger pieces into manageable sizes where feasible. - Keep a first aid kit readily available and ensure at least one person on site is trained in first aid in case of injury. - Prohibit distractions such as mobile devices in the work area to maintain focus on the task. - Inform all workers of emergency procedures and nearest emergency exits before starting work. - Assign tasks based on an individual's capacity, ensuring that none are overburdened beyond their physical capabilities. - Inspect all tools and equipment before use to confirm they are suitable and in good working condition. - Implement a system for reporting hazards and incidents promptly so corrective actions can be taken swiftly. 	1L

Removing Glass Debris	Cuts or lacerations, Flying debris from broken glass	3H	<ul style="list-style-type: none"> - Ensure all workers are wearing appropriate Personal Protective Equipment (PPE), including cut-resistant gloves, safety goggles, and sturdy footwear to protect from cuts and eye injuries. - Utilise tools such as brooms and dustpans designed for handling glass to minimise direct contact with sharp edges. - Implement a systematic cleaning process where larger pieces of glass are carefully collected with gloved hands or specialised tools before sweeping up smaller debris. - Clearly demarcate the work area with warning signs and barriers to prevent unauthorised personnel from entering and potentially being exposed to hazards. - Deploy a dedicated waste container specifically designed for glass disposal that is properly labelled and has protective lining to prevent punctures and leaks. - Conduct a pre-work briefing to inform all team members of potential hazards related to broken glass and the correct procedures for safe removal. - Assign experienced personnel to lead the clean-up process and supervise less experienced workers to ensure compliance with safety protocols. - Use an industrial vacuum cleaner fitted with a HEPA filter to effectively remove small glass shards and dust without spreading them into the air. - Regularly inspect PPE and tools for any damage before use to ensure they provide adequate protection and support during the debris removal process. - Develop an emergency response plan detailing steps to handle accidents involving cuts or lacerations, ensuring first aid kits are readily accessible and staff trained in first aid are on hand. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
