### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Exposure to harmful chemical fumes, potential skin irritation or burns from direct contact with chemicals	3H	<ul style="list-style-type: none"> <li>- Conduct a risk assessment prior to beginning the task to identify specific hazards associated with each chemical.</li> <li>- Ensure all workers involved in the task are trained in safe handling techniques and are familiar with Safety Data Sheets (SDS) for each chemical being used.</li> <li>- Use only in well-ventilated areas to prevent the build-up of harmful fumes, and consider the use of mechanical ventilation if available.</li> <li>- Implement a buddy system, where possible, ensuring that no worker is alone when handling strong chemicals.</li> <li>- Store chemicals according to their respective SDS recommendations to prevent accidental mixing or exposure.</li> <li>- Utilise appropriate Personal Protective Equipment (PPE), such as gloves, goggles, face shields, and aprons, specifically rated for the chemicals being handled.</li> <li>- Segregate incompatible chemicals to prevent dangerous reactions.</li> <li>- Clearly label all containers and ensure that labels are easy to read and understand by all workers.</li> <li>- Establish emergency procedures, including eye wash stations and safety showers, located near areas where chemicals are used.</li> <li>- Regularly inspect storage and handling equipment for signs of wear or leakage and replace as needed.</li> <li>- Limit the quantity of chemicals in use at any time to reduce the potential impact in case of an accidental spill or release.</li> <li>- Instruct workers never to eat, drink, or smoke in areas where chemicals are stored or used.</li> <li>- Provide proper hand washing facilities and encourage workers to wash their hands thoroughly after handling chemicals.</li> <li>- Develop and communicate clear procedures on how to report and respond to chemical spills or exposures immediately.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
