Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Electrical hazards, manual handling injuries	2M	<ul style="list-style-type: none"> - Conduct a pre-start inspection to identify any electrical hazards, ensuring power sources are well isolated and tagged out if necessary. - Use insulated tools and equipment when working near electrical systems to minimise the risk of electrical shock. - Identify and mark all electrical points on the job site, keep clear of these areas while moving drywall sheets. - Ensure that all personnel are trained in manual handling techniques to reduce the likelihood of strain or injury when lifting and carrying drywall sheets. - Utilise mechanical aids such as trolley and hoists wherever possible to assist in transporting heavy materials like drywall sheets. - Implement two-person lifting techniques for drywall sheets that exceed safe single-person lifting weights. - Provide appropriate personal protective equipment (PPE) such as gloves and safety boots to protect against potential cuts and crush injuries during handling. - Designate specific pathways for material transport to avoid congested areas that could increase the risk of slips, trips, or falls. - Ensure floors and workspaces are kept clean and free from debris that could interfere with safe manual handling and movement. - Inform and train workers on emergency procedures related to electrical hazards including identifying signs of electrical faults like sparking or malfunctioning equipment. - Schedule regular breaks for workers involved in manual handling tasks to prevent fatigue, which can lead to increased risk of injury. - Review and revise risk assessments and control measures regularly to ensure they remain effective and relevant to current work conditions. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
