### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Electrical hazards, Falling material	2M	<ul style="list-style-type: none"> <li>- Conduct a thorough risk assessment to identify all potential hazards related to electrical systems and equipment before beginning the shutdown procedure.</li> <li>- Ensure that all workers involved are trained in electrical safety and emergency shutdown procedures specific to the site.</li> <li>- Implement lockout/tagout (LOTO) procedures to ensure that machinery and electrical systems are properly de-energised and cannot be accidentally re-energised during the shutdown.</li> <li>- Provide and require the use of appropriate personal protective equipment (PPE), such as insulated gloves and footwear, hard hats, and safety goggles, for all personnel involved in the shutdown process.</li> <li>- Establish a clear communication plan, including hand signals or radios, to maintain contact between workers and supervisors ensuring prompt identification and response to hazards or emergencies.</li> <li>- Place adequate barriers, signs, and warning notices around the work area to prevent unauthorized access during the shutdown process and alert others to potential risks.</li> <li>- Arrange for a designated safety officer or team member to supervise the shutdown process, ensuring adherence to safety procedures and quick response to any incidents.</li> <li>- Keep tools and equipment organized and stored properly to prevent tripping hazards and ensure easy access when needed, reducing potential exposure to hazards from clutter.</li> <li>- Regularly check overhead structures and attachments for stability and secure any loose material or equipment that could fall during the shutdown.</li> <li>- Develop an emergency response plan that includes evacuation routes, first aid measures, and contact information for local emergency services, ensuring all workers are familiar with the plan in case of an incident.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
