### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Use appropriate tack and equipment that is well-maintained and suited to the specific horse and rider to prevent equipment failure.</li> <li>- Establish clear communication signals between the trainer, rider, and any ground staff to ensure coordinated actions and responses during training.</li> <li>- Encourage riders to maintain a balanced position and posture to enhance control and minimise the risk of falling.</li> <li>- Practice emergency dismount techniques in a controlled environment to prepare riders for safe exits if necessary.</li> <li>- Limit the number of horses being trained simultaneously to avoid distractions and reduce the potential for accidents caused by interaction between horses.</li> <li>- Designate specific training areas with even non-slip surfaces free of hazards such as rocks, holes, or other objects that could cause a horse to stumble.</li> <li>- Ensure all participants and staff are briefed on emergency procedures and first aid in case of an accident.</li> <li>- Gradually introduce potentially distracting elements (e.g., loud noises, unfamiliar animals) so both horse and rider can adjust safely.</li> <li>- Regularly review and update safety protocols based on near misses or incidents within the training environment to continually improve safety measures.</li> </ul>

Grooming and feeding	Bites, Kicks from horse	3H	<ul style="list-style-type: none"> <li>- Ensure all staff involved are trained and competent in horse handling.</li> <li>- Approach horses calmly and confidently, always from the front or side, to avoid startling them.</li> <li>- Maintain a safe distance from the horse's hindquarters to minimise the risk of being kicked.</li> <li>- Wear appropriate personal protective equipment such as sturdy boots and gloves.</li> <li>- Use appropriate, well-maintained tack and grooming equipment to ensure control over the horse.</li> <li>- Secure the horse using cross-ties or in a stable to limit its movement while grooming or feeding.</li> <li>- Be vigilant for signs of discomfort or agitation in the horse and take immediate steps to calm it.</li> <li>- Always keep hands clear of the horse's mouth when feeding to prevent bites.</li> <li>- Feed horses individually where possible to reduce competition that could lead to aggressive behaviour.</li> <li>- Ensure the working environment is quiet and has minimal distractions to prevent the horse from becoming startled.</li> <li>- Regularly inspect and maintain all feeding and grooming areas to remove hazards that might cause the horse to become stressed or reactive.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
