Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Inspection	High pressure fluid, Pinch points	2M	<p>The following control measures should be implemented for the work step "Inspection" to reduce or eliminate the identified hazards - high pressure fluid and pinch points:</p> <ul style="list-style-type: none"> - Conduct regular equipment inspections to ensure that hydraulic hoses, seals, and valves are in good condition and free from leaks. - Implement a systematic pre-operation inspection procedure, including visual checks for any damages or malfunctions. - Ensure that all operators and relevant personnel are trained on how to correctly position, use, and maintain the hydraulic cropper. - Maintain updated manufacturer's instructions and equipment guidelines, ensuring that these are readily accessible by the operators. - Establish a designated exclusion zone around the work area to prevent unauthorised access and minimise the risk of injuries. 	1L

			<ul style="list-style-type: none"> - Utilise suitable personal protective equipment (PPE), such as safety glasses, gloves, and steel-toed boots, when handling and inspecting the equipment. - Provide clear signage informing the employees about the possible hazards related to the hydraulic cropper usage and inspection. - Operate the hydraulic cropper at appropriate pressures as recommended by the manufacturer, to avoid stress on equipment components and high-pressure fluid release. - Do not exceed the specified weight limits while using the hydraulic cropper, as this may cause additional strain on the system, increasing the risk of high pressure fluid hazards. - Implement a lockout/tagout procedure to ensure that the hydraulic cropper is de-energised and rendered safe during inspection and maintenance tasks. - Regularly check and calibrate pressure relief valves to ensure they are operating effectively and preventing over-pressurization. - Develop and communicate emergency procedures in case of high-pressure fluid release incidents, including first aid and spill containment measures. - Ensure that all moving parts and pinch points are adequately guarded, reducing the risk of accidental contact and injury. - Schedule periodic audits and assessments of the implemented control measures to evaluate their effectiveness and make necessary improvements to further enhance workplace safety.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
