Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Machinery malfunction, Improper staff training	3H	<ul style="list-style-type: none"> - Ensure comprehensive servicing and maintenance of the hydraulic press regularly to prevent machinery malfunction. - Develop a routine check list for inspection of hydraulic press before initiating any work. - Lay out detailed guidelines, manuals and procedures for staff to follow while operating the hydraulic press. - Initiate intensive training programmes for staff to get them acquainted with the operation of hydraulic press and safety practices, fulfilling the requirement of WHS competency. - Make sure that only authorised and trained personnel operate the machinery, reducing the risk posed by improper staff training. - Create an emergency plan including cessation of work processes in case there is any sign of machinery malfunction. - Install high quality emergency stop push buttons at multiple, easily accessible locations near the hydraulic press. - Use visual warning systems like flashing lights or audible alarms to alert operators of potential faults/malfunctions with the machine. - Arrange regular audits of safety protocols to ensure they are being followed accurately and assess their effectiveness in real-time conditions. - Equip the workforce with necessary Personal Protective Equipment (PPE) such as safety shoes, gloves, safety glasses etc., to safeguard them from potential hazards. - Foster a culture of safety where employees are encouraged to report any perceived risks, safety shortcomings or incidents without any fear of reprisals or backlash. 	2M

Never try to make due with what's on hand if it's not fit for purpose. - Enforce strict adherence to lockout/tagout procedures to prevent accidental machine operation during maintenance or downtime. - Visual inspections should be carried out to detect fluid leaks, unusual vibrations, or excess heating. - Regularly maintain and service hydraulic machines according to manufacturer instructions. 	2M

Operating hydraulic press	Hands trapped, Eye injury from flying debris	4A	<ul style="list-style-type: none"> - Promote and enforce the use of Personal Protective Equipment (PPE) such as safety gloves, eye protection and heavy-duty footwear. This will protect against hand injuries and eye injury by flying debris. - Ensure that a comprehensive risk assessment is carried out before operating the hydraulic press, identifying potential hazards and how to mitigate them. - Operators should be adequately trained on how to use the equipment safely, including knowledge on the correct placement of hands and understanding the risks involved. - Encourage regular breaks to prevent fatigue and loss of concentration, which may lead to mistakes and accidents. - Install machine guards to shield the operator from any high-speed particles or fragmentary materials. - Regularly service and maintain the hydraulic press to ensure it's working optimally and safely. Any malfunctioning parts should be repaired or replaced promptly. - Implement an 'Emergency Stop' button that can instantly halt the machine in the event of an emergency. - Clear the workspace of unnecessary items to prevent tripping or other forms of accidents caused by clutter. - Use well-designed tools and fixtures that hold the workpiece securely during pressing operations, reducing the chances of slippages that could cause hand entrapment. - Develop and implement standardised operating procedures to ensure consistency and safety while operating the hydraulic press. - Encourage a culture of safety where workers feel comfortable reporting hazardous conditions or unsafe behaviours. - Enforce a strict 'no bypassing safeguards' policy. All protections provided must be used appropriately and consistently. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
