Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Machine Inspection	Amputation, Crush Injuries, Exposed to Extreme Cold	3H	<ul style="list-style-type: none"> - Conduct a pre-operation safety briefing to remind workers of the hazards associated with the machine and the inspection process. - Ensure all operators have completed relevant training in machine operation and hazard recognition, and that they hold current certification if required. - Use personal protective equipment (PPE) such as cut-resistant gloves, insulated clothing, and safety goggles to protect against severe cold, moving parts, and sharp edges. - Implement a lockout/tagout procedure to ensure the machine is de-energised and cannot be accidentally started during inspection. - Perform visual checks for any signs of damage or excessive wear on machine components, and address issues before operation. - Insulate exposed cold surfaces where possible, to prevent direct contact with extreme temperatures. - Install visible and clear signage that warns of entrapment and crush points, and highlights emergency stop button locations. - Maintain a safe distance from moving parts when visually checking operational functionality. 	2M

Machine Operation	Frostbite, Noise Induced Hearing Loss	3H	<ul style="list-style-type: none"> - Provide appropriate personal protective equipment (PPE) such as insulated gloves to prevent frostbite from coming into contact with cold surfaces. - Ensure operators are trained in the safe handling of ice machines, focusing on recognising and mitigating frostbite risk. - Implement regular checks and maintenance schedules for the ice machine to ensure it is functioning correctly and there are no leaks or defects. - Install noise barriers or sound-dampening materials around the ice machine to reduce noise levels and minimise risk of hearing loss. - Conduct regular noise level assessments to ensure the working environment complies with the acceptable standards for occupational noise exposure. - Use signage to clearly label areas with high noise levels and require workers to use hearing protection when operating the ice machine or nearby. - Implement administrative controls such as rotating shifts and limiting time spent near the ice machine to reduce prolonged exposure to both cold and noise. - Encourage the use of specialised ear protection suited for environments involving low-frequency machinery noise to prevent noise-induced hearing loss. - Ensure clear communication of emergency procedures and first aid measures related to cold exposure and hearing damage among all staff members. - Arrange for routine health surveillance and hearing tests for employees who regularly operate or work near the ice machine. - Develop and enforce standard operating procedures (SOPs) specifically addressing safe practices for starting, operating, and shutting down the ice machine. - Make certain that workspaces around the ice machine are clutter-free to avoid accidental slips or falls that could result in direct contact with cold surfaces. - Educate workers on recognising early symptoms of frostbite and hearing loss, encouraging prompt reporting and intervention if any symptoms arise. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
