Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Implement clear signage around identified work zones to alert staff and visitors to potential hazards associated with tree identification tasks. - Equip workers with personal protective equipment (PPE) including gloves, boots, long-sleeved clothing, and hats to prevent injuries when navigating through dense foliage or underbrush. - Provide and use communication devices such as radios or mobile phones for workers to stay in contact should they encounter wildlife or require assistance. - Perform a wildlife assessment or consultation with local wildlife experts before commencing work to identify possible animal encounters, especially with aggressive or dangerous species. - Carry first-aid kits and ensure personnel are trained in administering first aid, particularly for animal bites or stings. - Schedule tree identification activities during periods when wildlife is less active to minimise disturbances and reduce encounter probabilities. - Ensure that team members work in pairs or small groups for increased safety and quick response to any emergency situations involving animals. - Maintain an up-to-date emergency response plan that includes procedures for handling animal encounters and injuries from either misjudgement in size or other related incidents.

Equipment Setup	Electrical faults, Incorrect use of equipment	3H	<ul style="list-style-type: none"> - Conduct thorough inspection of all equipment for any visible damage or wear before use. - Ensure testing and tagging of electrical equipment is up to date according to relevant safety standards. - Provide comprehensive training to all personnel on the correct usage and handling of each piece of equipment. - Use Residual Current Devices (RCDs) to prevent electrical faults and provide additional protection against electric shock. - Implement lockout/tagout procedures to ensure equipment is de-energised during maintenance or repair work. - Establish clear communication protocols among team members during equipment setup to avoid misunderstandings. - Maintain an exclusion zone around setup areas to protect non-essential personnel from hazards. - Verify that all power cords are positioned safely to prevent tripping hazards, and are kept away from water sources. - Regularly calibrate equipment to ensure it operates within manufacturer specifications and reduces risk of malfunction. - Use Personal Protective Equipment (PPE) like insulated gloves and footwear when setting up electrical equipment. - Keep a fire extinguisher and first aid kit readily accessible near the setup area for quick response in emergencies. - Develop and follow a checklist for verifying that each piece of equipment is set up correctly and safely. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
