ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Lighting Installation	Electrical shock, Falling objects	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to beginning installation to identify specific electrical hazards and implement appropriate controls. - Ensure all personnel involved in the lighting installation are trained, qualified, and competent in working with electrical systems. - Use insulated tools and wear rubber-soled footwear to minimise the risk of electrical shock. - De-energise circuits and use lockout/tagout procedures before working on any electrical components. - Keep work areas free from water or dampness that may increase the risk of electrical shock. - Secure all tools and materials at height to prevent them from falling and injuring workers below. - Install temporary guardrails or barriers under elevated work areas to protect people from falling objects. - Ensure proper Personal Protective Equipment (PPE) such as helmets and gloves is used by all workers. - Use safety harnesses and lanyards when working at heights where applicable. - Maintain communication among team members to quickly address any potential hazards observed during the work process. - Regularly inspect all equipment and tools for damage or wear that could lead to electrical failures or accidental drops. 	2M

<p>2M</p> <p>Unsecured tools</p>	<ul style="list-style-type: none"> - Use cord management solutions such as cable trays or organisers to ensure all cords are tucked away or secured and not hanging down. - Conduct a walk-through of the workspace to identify and remove any clutter that could cause stumbling. - Install tool holders or racks to secure tools when not in use, reducing the chance of misplacement. - Clearly mark pathways with reflective tape or paint to guide workers and avoid congested conditions. - Position cords away from high-traffic areas where they are more likely to be tripped over. - Ensure adequate lighting is available, using portable lamps or brighter overhead lights to clearly illuminate the workspace. - Maintain an organised workspace, reducing the chance of misplacement of tools and equipment. - Educate employees about the importance of keeping their personal work areas free of clutter and hazards. - Conduct regular checks and maintenance of lighting fixtures to ensure they are functioning properly. - Design designated spots for tools and equipment to ensure they are easily accessible and not cluttered. - Introduce a "clean as you go" policy, encouraging workers to immediately clean up spills and debris. - Utilise anti-slip mats in areas where there may be an increased risk of spills. - Display clear signage warning of potential trip hazards in poorly lit or cluttered areas.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
