ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

2. Site Assessment	Collision with stationary objects, Falling objects	2M	<ul style="list-style-type: none"> - Conduct a pre-work site inspection to identify stationary objects that might pose collision risks. - Clearly mark out the work zone using high-visibility barriers and signage to warn of stationary hazards. - Ensure all team members are equipped with high-visibility clothing to increase awareness around stationary objects. - Place protective covers or padding on any protruding or sharp stationary objects if they are in close proximity to the work area. - Use spotters when navigating bulky materials or equipment around obstacles to prevent collisions. - Implement exclusion zones beneath areas where work is being conducted overhead to minimise risk from falling objects. - Regularly check that all tools and equipment used at height are securely fastened or tethered to prevent them from accidentally falling. - Store all materials, especially loose ones, away from edges and secure them against unexpected weather conditions like strong winds. - Conduct regular team briefings to reinforce the importance of site awareness, especially around stationary objects. 	1L

Equipment Transport	Heavy lifting related injuries, Traffic accident		<ul style="list-style-type: none"> - Use forklifts or pallet jacks for moving heavy equipment to prevent manual handling injuries. - Implement a traffic management plan when transporting equipment on-site, including designated pathways and entry points. - Ensure all personnel involved in lifting operations are trained in proper lifting techniques. - Conduct a pre-lift assessment to determine the safest method for transport and lifting of heavy items. - Secure the electronic scoreboard properly during transportation using appropriate restraints and fasteners. - Use spotters as necessary to guide vehicles and ensure safe manoeuvring around obstacles. - Maintain open communication between drivers and ground crew using two-way radios or hand signals. - Inspect transport vehicles regularly to ensure they are in good working condition before use. - Employ licensed and experienced drivers for operating vehicles transporting heavy equipment. - Plan transport routes in advance, avoiding high traffic areas and hazardous road conditions where possible. - Limit transportation activities to daylight hours to enhance visibility and reduce accident risk. - Provide clear signage on transport vehicles indicating that they are carrying oversized loads and require additional caution. 	1L



SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
