Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Inadequate training, improper use of tools	3H	<ul style="list-style-type: none"> - Ensure all workers involved in the installation have current and relevant training certifications. - Conduct a toolbox talk prior to commencing work to discuss potential hazards and control measures specific to the task. - Provide induction for new workers, covering tool use and safety procedures related to the task. - Develop and implement a job safety analysis (JSA) for the installation process to identify and control site-specific risks. - Use only tools that are well maintained and appropriate for the tasks outlined in the manufacturer's instructions. - Inspect all tools and equipment before use to ensure they are in safe working condition. - Provide personal protective equipment (PPE) such as gloves and safety glasses to protect against tool-related injuries. - Offer refresher courses on the correct use of hand and power tools for all team members regularly. - Supervise inexperienced workers closely until they demonstrate competence with tools and procedures. - Promote the buddy system, pairing less experienced workers with seasoned professionals for guidance. - Maintain a clean and organised work area to minimise trip hazards and improve access to tools and materials. - Avoid using damaged or makeshift tools by ensuring replacements are accessible and properly stored. - Implement a lockout/tagout system to ensure tools are not used when maintenance is being performed. - Clearly label and store chemical substances away from the work zone to prevent any accidental misuse or contamination during the preparation stage. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
