ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper handling, Ineffective communication	2M	<ul style="list-style-type: none"> - Conduct a toolbox talk before commencing work to ensure all team members understand their roles and responsibilities. - Ensure proper manual handling techniques are demonstrated and practiced to prevent strain injuries when lifting or moving equipment and materials. - Use appropriate personal protective equipment such as gloves and safety boots to minimise the risk of injury from sharp edges or heavy items. - Ensure all workers are trained and competent in the tasks they will be performing, specifically in relation to backflow prevention devices. - Establish clear communication protocols, including the use of hand signals or radios, especially in noisy environments where verbal communication may be difficult. - Inspect all tools and equipment to ensure they are in good working condition before use to avoid malfunction or accidents. - Mark and secure the work area with barriers or cones to prevent unauthorised access and to protect both workers and the public. - Prepare a SWMS outlining the specific steps and precautions to be taken during the installation process and ensure it is reviewed before starting work. - Identify and clarify the location of existing underground services to avoid accidental damage during preparation work. - Utilise mechanical aids such as dollies or forklifts for transporting heavy materials to reduce the risk of manual handling injuries. - Assign a designated observer to oversee the work and ensure adherence to safety procedures and communicate any hazards. - Keep an emergency first aid kit accessible on-site and ensure at least one team member is trained in first aid response. - Develop a contingency plan with clear instructions for stopping work and evacuating the site in case of an emergency situation. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
