Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Equipment Setup	Incorrect tool usage, Falls from equipment	3H	<ul style="list-style-type: none"> - Conduct a pre-start safety briefing to ensure all team members are aware of correct tool usage and potential hazards. - Use only tools and equipment that are specifically designed for brake system installation, ensuring they are in good condition and regularly maintained. - Provide training on the proper use and handling of each tool to prevent misuse or accidental injury. - Implement a toolbox check before starting the job to verify that all necessary tools are available and functional. - Clear the work area of unnecessary clutter to minimise trips and falls during equipment setup. - Use lockout/tagout procedures to isolate energy sources when setting up equipment, reducing the risk of accidental startup. - Employ personal protective equipment (PPE) such as gloves and safety glasses to prevent injuries from sharp tools and debris. - Secure ladders and scaffolding properly to reduce the risk of falls during elevated work. - Ensure floors and work surfaces are non-slip and free from oil, grease, or other substances. - Have fall protection measures like guardrails or harness systems for any work conducted at heights. 	1L

Component Inspection	Exposure to harmful substances, Eye strain	2M	<ul style="list-style-type: none"> - Wear appropriate personal protective equipment (PPE) such as gloves and eye protection to minimise exposure to harmful substances. - Use fume extraction systems or adequate ventilation when inspecting components that may emit harmful vapours. - Conduct regular air monitoring to ensure exposure levels are within safe limits. - Follow Material Safety Data Sheets (MSDS) for handling all chemicals and substances used during inspection. - Implement a hygiene protocol including washing hands and face after handling any components or substances. - Rotate personnel regularly to reduce the risk of prolonged exposure that could lead to cumulative health effects such as skin conditions or respiratory issues. - Utilise adjustable inspection benches to keep components at a comfortable working height, reducing the need for bending or awkward postures that could contribute to musculoskeletal disorders. - Schedule mandatory breaks and ensure adequate lighting to prevent eye strain from extended periods of fine-detail inspection. - Use magnifying tools or visual aids to reduce the need for excessive eye focusing at close distances. - Keep work areas clean and organised to prevent accidental spills and contamination with harmful substances. - Train workers on recognising symptoms of exposure to specific harmful substances, ensuring prompt response and reporting. - Store hazardous materials securely and label all chemical containers clearly to avoid accidental misuse. - Implement a comprehensive safety induction program focused on hazard awareness and the proper use of protective equipment. - If necessary, conduct periodic health surveillance for workers involved in tasks with potential exposure to harmful substances. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
