Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Wear appropriate personal protective equipment (PPE) including high-visibility clothing, hard hats, gloves, and hearing protection. Set up exclusion zones around the unloading area to keep unauthorised personnel at a safe distance. Conduct a pre-operational inspection of all lifting equipment to ensure it is in good working condition. Ensure that all staff involved are trained and competent in manual handling techniques and equipment operation. Use height safety equipment such as harnesses and barriers if working at elevated levels during unloading. Ensure that drive plates are secured properly during transportation to prevent shifting or falling. Remind all personnel to keep fingers and toes clear from pinch points when moving or placing the plates. The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised.
