Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Manual handling injuries, Slippery surface	3H	<ul style="list-style-type: none"> <li>- Conduct a manual handling risk assessment prior to the work commencing to identify potential hazards and control measures.</li> <li>- Provide training for workers on safe manual handling techniques, emphasising the importance of good posture and using leg muscles instead of back muscles.</li> <li>- Use mechanical aids such as dollies, hoists, or cranes to lift and transport heavy components whenever possible to minimise manual lifting.</li> <li>- Ensure the work area is kept clear and organised to prevent trips and slips, especially in areas where flywheel components are being staged or installed.</li> <li>- Install anti-slip mats or apply anti-slip coatings to floors and surfaces where the installation takes place to reduce slip hazards.</li> <li>- Encourage team lifts for heavy or awkward items when mechanical aids are not feasible, ensuring all workers are properly briefed on coordination and technique.</li> <li>- Establish clear walkways and working zones marked with high-visibility tape to guide workers and keep them aware of their surroundings.</li> <li>- Implement a job rotation system to avoid prolonged periods of manual handling by any one worker, reducing the risk of repetitive strain injuries.</li> <li>- Provide appropriate personal protective equipment (PPE) such as gloves with good grip and supportive footwear with slip-resistant soles.</li> <li>- Schedule regular housekeeping throughout the workday to remove debris, tools, or materials that may create slippery surfaces or obstruct pathways.</li> <li>- Place "Wet Floor" signs or warning cones immediately if any spillages occur, and ensure prompt cleanup and drying of the affected area.</li> <li>- Review and update the Safe Work Method Statement (SWMS) regularly to incorporate any new learnings or changes in the workplace environment related to safety practices.</li> <li>- Assign a safety observer during critical phases of the task to monitor and guide manual handling activities, offering real-time advice and intervention if necessary.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
