Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Tripping hazards, Electrical risks (from cables and power sources)	3H	<ul style="list-style-type: none"> - Conduct a site walk-through to identify and mark any tripping hazards such as uneven surfaces or debris, ensuring they are barricaded or marked with warning signs. - Ensure all team members are wearing appropriate personal protective equipment (PPE) like safety boots to minimize injury risk from trips. - Set up clear and tidy pathways for personnel and equipment to prevent accidental contact with tripping hazards. - Use cable covers or route electrical cables overhead wherever possible to avoid creating additional trip hazards on the ground. - Regularly inspect and maintain all tools and equipment to prevent malfunctions that could lead to unsafe conditions during installation. - Implement a clear communication plan to ensure that all workers are aware of potential hazards and control measures on the site. - Designate a safety officer or supervisor responsible for monitoring compliance with safety protocols and immediately addressing unsafe conditions. - Ensure workers have received proper training on identifying and avoiding tripping and electrical hazards specific to the site. - Equip the site with appropriate lighting to enhance visibility and reduce the likelihood of tripping or coming into contact with electrical risks. - Clearly label all electrical sources and switches connected with the work area; ensure they comply with relevant Australian electrical and safety standards. - Establish a lock-out/tag-out procedure to secure all energised systems before beginning work to prevent accidental activation of power sources. - Utilise ground-fault circuit interrupters (GFCIs) when using electrical equipment outdoors or in damp environments to reduce the risk of electric shock. 	2M

			<ul style="list-style-type: none"> - Clearly label all storage areas for tools and equipment, keeping sharp-edged tools separate from other items to minimise accidental cuts. - Conduct regular training sessions on hazard awareness, emphasising the specific risks associated with sharp edges and heavy equipment handling. - Keep work areas tidy and organized, ensuring tools are stored securely to reduce trips, slips, and falls, and limit access to the general walking path. - Establish clear communication signals for anyone involved in lifting or moving heavy equipment, reducing strain and potential mishaps. - Limit the time spent handling heavy equipment manually, introducing job rotation schedules to reduce fatigue-related accidents. - Post safety signage around the workspace reminding workers of the dangers posed by sharp tools and equipment, reinforcing awareness. - Ensure adequate lighting to ensure all hazards, including sharp edges, are visible at all times during equipment collection. - Provide accessible first aid kits at multiple locations onsite, allowing quick response in case of cuts or other injuries. - Develop emergency procedures that include protocols for dealing with incidents involving sharp tools or heavy equipment, ensuring all workers know steps to take should an accident occur.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
