Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Incorrect lifting technique, Tripping over equipment or cables	3H	<ul style="list-style-type: none"> - Conduct training sessions for workers on proper lifting techniques and posture to minimise the risk of injury. - Use mechanical aids such as trolleys, dollies or lifts to assist with moving heavy equipment, reducing manual handling tasks. - Implement a clear site layout plan to organise equipment and materials, ensuring walkways are free from obstructions and trip hazards. - Utilise spotters to guide and assist workers when carrying large or awkward loads through congested areas. - Ensure all staff wear appropriate personal protective equipment, including steel-toed boots with non-slip soles to protect against slips and trips. - Mark safe routes and cover cables with cable protectors to prevent tripping, especially in high-traffic areas. - Regularly inspect walkways and work areas to promptly remove any unnecessary tools or debris that could pose a trip hazard. - Establish safe zones for storing tools and equipment, clearly demarcated to prevent encroachment into pathways. - Post visible safety signage that instructs personnel on safe walking paths and highlights areas where caution is needed. - Schedule regular breaks and rotation for tasks involving manual handling to reduce fatigue, maintaining alertness to potential hazards. 	2M

Site Assessment	Falls from height, Electric shock from exposed wires	4A	<ul style="list-style-type: none"> - Ensure all workers are equipped with appropriate fall arrest systems, including harnesses and anchor points, when working at heights. - Conduct a thorough site inspection to identify potential hazards, such as unstable surfaces or nearby power lines, and implement control measures before work begins. - Erect secure scaffolding or use cherry pickers where necessary to provide stable working platforms at height, ensuring equipment is regularly inspected for safety compliance. - Implement exclusion zones around the installation area to prevent unauthorised personnel from entering hazardous areas during work operations. - Use non-conductive ladders and tools to reduce the risk of electric shock when working near electrical components or wiring. - Isolate and de-energise electrical circuits in the work area prior to commencing installation tasks, using lockout/tagout procedures to ensure circuits remain deactivated. - Provide personal protective equipment (PPE) such as insulated gloves, protective eyewear, and hard hats to safeguard against electrical hazards and falling objects. 	2M

Equipment Setup	Inadequate grounding, Faulty equipment		<ul style="list-style-type: none"> - Conduct a visual inspection of all electrical equipment and cords to ensure they are free from damage or wear before setting up. - Use only equipment that has been tested and tagged in accordance with Australian Standards AS/NZS 3760. - Ensure that all electrical connections are properly grounded according to manufacturer's instructions and local regulations. - Provide adequate training for workers on the proper setup and usage of heat pump installation equipment. - Verify that circuit breakers and grounding systems are in place and functioning correctly before commencing work. - Use residual current devices (RCDs) to provide additional protection against electrical faults during equipment operation. - Clearly label all equipment with operating instructions and hazard warnings. - Keep the work area dry to prevent electrical hazards, positioning equipment away from potential water sources. - Implement a regular maintenance schedule for all tools and machinery involved in the installation process. - Replace any faulty or damaged equipment immediately to avoid potential risks. - Keep a detailed log of inspections and maintenance carried out on equipment, ensuring compliance with safety protocols. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
