If an incident or a near miss occurs, all work must sto, an atately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Equipment Check	Defective equipment, Electrical hazards	ЗН	 Conduct a pre-use inspection of all tools and equipment to identify any defects or damage. Ensure all electrical equipment has been tested and tagged in accordance with Australian standards. Use only equipment that is suitable for the task and ensure it meets the required safety specifications. Have a system in place for promptly removing defective equipment from service to prevent accidental use. Implement a regular maintenance schedule for all tools to ensure they are in good working order. Ensure all workers are trained on the proper use and handling of the equipment. Use insulated tools when working near electrical sources to minimise the risk of electric shock. Keep work areas dry and free from moisture to prevent electrical hazards. Ensure power supply to equipment is properly grounded before starting work. Use Residual Current Devices (RCDs) where required, particularly with portable electrical equipment. Store tools and equipment in designated areas to avoid damage and allow for easy access during inspections. Clearly label all equipment with instructions and safety precautions to ensure safe operation. 	1L



Use appropriate personal protective equipment (PE) such as cut-resistant gloves to protect hands from sharp edges. Plan and clear the unpacking area to preventipe to to reduce the need for manual lifting and moving activities. Utilise mechanical aids like trolleys or pallet jac to reduce the need for manual lifting where possible. Inspect packaging before opening to identify any intential azards or sharp edges that could cause injury. Assign team lifting where and line reavier parts of distribute the load evenly and prevent musculoskeletal injuries. Provide adequate lighting in the work of a consure full visibility of potential hazards and facilitate safe hand. Keep Well-stock of irst aid kit nearby in case of cuts or other minor injuries, and ensure all workers know it location. Committee and enferce safe work procedures on lifting and handling among all team members prior to minimise the risk of injuries. Rotation is among team members to prevent fatigue-related accidents or injuries from continuous avy lifting. Conduct a pre-start toolbox talk focusing on lifting practices and the specific risks associated with unpacking car parts. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors as support ractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
