ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Site Assessment	Electric shock, Working in Public areas	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection before commencing work to identify potential electrical hazards and any live wires in the area. - Implement isolation procedures by de-energising all circuits and using lockout/tagout systems to prevent accidental energisation during the installation process. - Use insulated tools and wear appropriate personal protective equipment (PPE) such as rubber gloves, boots, and insulating mats to reduce the risk of electric shock. - Set up barriers and warning signs around the work area to keep unauthorised personnel and members of the public at a safe distance. - Ensure all workers are trained and competent in working with high voltage equipment and understand the risks associated with transformers. - Establish a communication plan among all team members, including emergency contacts and procedures for reporting incidents or hazards onsite. - Regularly test and tag all electrical equipment and tools used during the installation to ensure they are in good working order. - Develop an emergency response plan specific to the site, detailing actions to take in case of electric shock or other dangers. 	2M

Transport Transformers	Traffic interaction, Manual Handling	2H	<ul style="list-style-type: none"> - Develop a detailed traffic management plan to manage vehicle and pedestrian interactions in the work area. - Use clearly visible signage and barriers to direct and control site traffic and prevent unauthorised access to the loading and unloading zones. - Schedule transportation during off-peak hours to minimise interaction with other site activities and public traffic. - Ensure all transport vehicles are fitted with reverse alarms, lights, and mirrors for enhanced visibility and safety. - Conduct thorough checks and maintenance on forklifts and cranes to ensure they are fit for purpose and safely rated for the required loads. - Assign experienced and licensed operators for the operation of heavy machinery, such as forklifts and cranes, involved in transporting transformers. - Implement safe manual handling techniques training for workers to reduce risk of injury from lifting or moving heavy objects associated with transformer transportation. - Utilise mechanical aids, such as hand trolleys or dollies, whenever possible to reduce manual lifting requirements. - Conduct pre-task meetings to communicate potential hazards and control measures to all staff involved with transporting transformers. - Employ spotters to help guide drivers and machinery operators when maneuvering in tight or congested spaces to avoid incidents and improve safety. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
