Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Material mishandling, falls from height	3H	<ul style="list-style-type: none"> - Conduct thorough site inspections to identify potential hazards and ensure all team members are briefed on the risks associated with the work. - Use mechanical lifting equipment such as cranes or forklifts to handle heavy materials, minimising manual handling. - Ensure all employees involved have completed proper training in manual handling techniques and working at heights procedures. - Install guardrails and edge protection systems on elevated work areas to prevent falls. - Employ safety harnesses and fall arrest systems for workers operating at heights, ensuring equipment is regularly inspected and maintained. - Clearly mark and barricade no-go zones underneath overhead work to protect other workers from falling objects or debris. - Develop and follow a comprehensive Safe Work Method Statement (SWMS) that outlines all steps and controls to be implemented for overhead structure installation. - Coordinate site activities to minimise overlaps between different trades, reducing the chance of congestion and accidents. - Regularly review and update safety procedures to adhere to current workplace health and safety regulations. - Assign a designated safety officer to oversee operations and ensure compliance with all prescribed safety measures. 	2M

Site Assessment	Risks of electrocution, incompatible work activities	3H	<ul style="list-style-type: none"> - Conduct a thorough inspection of the site to identify any overhead power lines and maintain a safe distance as per Australian Standards. - Use non-conductive ladders and insulated tools when working near electrical sources to prevent electrocution. - Ensure that all workers are trained and made aware of the presence and location of overhead utilities before commencing work. - Implement exclusion zones through signage and barriers to restrict entry to areas under or near live overhead power lines. - Coordinate with utility providers to obtain accurate information about underground and overhead services, especially prior to digging or installation activities. - Review and plan compatible work schedules to avoid overlaps of different trades that could lead to conflicting operations on-site. - Utilise spotters when manoeuvring equipment near overhead structures to ensure safe clearances are maintained at all times. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
