### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Manual handling, Tripping over materials	2M	<ul style="list-style-type: none"> <li>- Conduct a pre-task hazard assessment to identify and manage any potential risks.</li> <li>- Use appropriate manual handling techniques to lift, carry, and position equipment or materials safely.</li> <li>- Arrange for team lifting or use mechanical aids for heavy or awkward items to prevent strain or injury.</li> <li>- Keep the work area clean and free of unnecessary clutter to minimise tripping hazards.</li> <li>- Clearly mark and secure all access points around the work area with safety barriers or signage.</li> <li>- Ensure adequate lighting in the workspace to improve visibility and prevent trips over unseen objects.</li> <li>- Store tools and materials in an organised manner away from pathways to prevent tripping.</li> <li>- Provide and use appropriate personal protective equipment such as gloves and safety footwear.</li> <li>- Train workers in ergonomic techniques to reduce strain during manual handling tasks.</li> <li>- Establish a clear communication protocol among workers to ensure coordination and alertness regarding any nearby hazards.</li> <li>- Review and comply with SWMS and other relevant workplace procedures prior to starting the job.</li> <li>- Position ladders or scaffolding securely on a stable surface to achieve safe working height levels.</li> <li>- Perform a walkthrough after setup to identify potential obstacles that could lead to tripping incidents.</li> <li>- Limit the number of personnel in the active work zone to reduce congestion and the risk of tripping.</li> </ul>	1L
2. Ladder Setup	Falling from height, Ladder instability	3H	<ul style="list-style-type: none"> <li>- Conduct a site inspection to ensure the ground is stable and flat before setting up the ladder.</li> <li>- Use a ladder that is appropriate for the height of the task and complies with Australian Standards.</li> <li>- Inspect the ladder for any damage or defects prior to use, including checking the stability of rungs and feet.</li> <li>- Erect the ladder at a safe angle, usually following the 4:1 ratio (one metre out for every four metres in height) to ensure stability.</li> <li>- Secure the ladder at the top if possible, using a suitable tie-off point to prevent sliding or movement.</li> <li>- Position the ladder on a non-slip surface or utilise rubber stabiliser pads if the surface is smooth or slippery.</li> <li>- Ensure only one person is on the ladder at any given time to maintain balance and prevent overloading.</li> <li>- Maintain three points of contact when climbing or working from the ladder to enhance stability and control.</li> <li>- Wear appropriate personal protective equipment such as non-slip footwear and a tool belt to avoid carrying tools by hand.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
