Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Site Inspection	Falls from height, Tripping over objects, Exposed to hazardous substances	3H	<ul style="list-style-type: none"> - Conduct a comprehensive risk assessment prior to beginning the site inspection to identify specific hazards related to the work area. - Ensure all workers involved in the inspection are provided with and are wearing appropriate personal protective equipment (PPE), including hard hats, safety boots, and high-visibility vests. - Install temporary edge protection, such as guardrails or safety barriers, around any potential fall zones to prevent falls from height during the inspection. - Clearly mark and signpost potential trip hazards on-site, ensuring that all tools and materials are organised and kept away from walkways. - Develop and communicate a safe work method statement (SWMS) specifically for the site inspection phase, outlining all steps, risks, and controls. - Ensure that all workers are adequately trained and briefed on the potential presence of hazardous substances and the proper handling procedures if they are observed during the inspection. - Use appropriate access equipment, such as scaffolding or ladders, that is properly secured and stable to minimise fall risks while inspecting elevated areas. - Assign a competent spotter to oversee and support workers conducting inspections at heights to ensure adherence to safety protocols. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
