ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. Preparation	Improper training, Inadequate PPE	2M	<ul style="list-style-type: none"> - Ensure all workers involved in the task have received adequate training on tyre chain installation procedures and safety protocols. - Conduct a pre-operation meeting to review the task, identify potential hazards, and discuss control measures with all team members. - Provide clear instructional materials, such as step-by-step guides or instructional videos, to supplement hands-on training. - Ensure that all personnel performing the task are equipped with appropriate personal protective equipment (PPE) including gloves, high-visibility clothing, and safety boots. - Regularly inspect and maintain PPE to guarantee its effectiveness and replace any damaged or worn-out equipment immediately. - Establish a designated safe zone for tyre chain installation, away from traffic and other hazards. - Use signage and barriers to clearly mark the work area and ensure no unauthorised personnel enter the site. - Implement a buddy system so workers can assist each other, providing an additional layer of safety oversight. - Assess weather conditions prior to commencing work to ensure it is safe to proceed, postponing if conditions are hazardous. - Document all training sessions and maintain records of participant attendance to ensure accountability and compliance. 	1L
2. Equipment Check	Faulty equipment, Incorrect handling	2M	<ul style="list-style-type: none"> - Conduct a visual inspection of tyre chains for wear and damage before use. - Verify that the tyre chains match the vehicle's tyre size to prevent incorrect fitting. - Regularly maintain and service equipment to ensure all components are in proper working order. - Ensure all employees are trained in identifying faulty equipment signs and proper handling techniques. - Use personal protective equipment, such as gloves, to prevent hand injuries when handling chains. - Implement a reporting system for faults or defects identified during equipment checks. - Store tyre chains properly after each use to reduce wear and prevent tangling or damage. - Assign a competent person to oversee equipment inspections and approvals before installation begins. - Provide a detailed checklist for employees to follow during equipment inspection and handling. - Establish clear communication channels for reporting issues with equipment during the check process. 	1L

- Use wheel chocks to secure wheels not being lifted with chains.
- Turn on hazard lights to increase visibility to other motorists.
- Conduct a visual inspection of the surrounding area for any obstructing vehicle.
- Place warning signs or cones around the work area to alert other motorists.
- Ensure adequate lighting is available, especially during low light conditions.
- Wear high-visibility clothing to increase personal visibility to passing motorists.
- Ensure weather conditions are safe and assess for any changes in visibility.
- Communicate clearly with all personnel involved to ensure every step is followed in sequence of tasks.
- Maintain a safe distance from the vehicle path when guiding its path.
- Establish a communication system using hand signals or radios.
- Provide proper footwear with non-slip soles to prevent slips and falls.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
