Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Inappropriate PPE, Incorrect use of equipment	2M	<ul style="list-style-type: none"> - Conduct a pre-task briefing to ensure all personnel understand the procedure and hazards. - Wear appropriate PPE such as insulated gloves and safety glasses to protect against electrical shocks and battery acid. - Use jumper leads that are in good condition, without frayed wires or damaged clamps. - Verify that the dead battery and the live battery have the same voltage and terminal connection type to prevent electrical damage. - Ensure that all equipment, including vehicles involved, is turned off before connecting jumper leads. - Position vehicles safely with enough space to avoid contact between them during the entire process. - Check for leaks, cracks, or swelling on the battery casing to avoid potential exposure to hazardous substances. - Read and follow the manufacturer's instructions for both vehicles and jumper leads. - Identify and keep tools needed for the task nearby, such as wrenches or pliers, to avoid disruptions mid-task. - Switch off any accessories or additional loads in both vehicles to reduce the risk of electric spikes. - Examine the environment for flammable materials or liquids nearby that could ignite from sparks. - Ensure that skills and levels of experience of all persons involved are adequate for the task. - Confirm there is a readily accessible first aid kit nearby in case of an incident. - Always attach jumper leads in the correct order and manner, starting with positive terminals followed by negative ones to minimise risk. 	1L

Check Vehicle	Violent battery explosion, Acid leaks, Sparks	3H	<ul style="list-style-type: none"> - Conduct a visual inspection of the battery for cracks, leaks, or damage before proceeding with any jump starting activities. - Ensure the vehicle is in a well-ventilated area to disperse any potentially explosive gases from the battery. - Wear appropriate personal protective equipment such as safety glasses and acid-resistant gloves to protect against harmful splashes. - Verify that both vehicles are turned off and in park or neutral position with the handbrake engaged. - Keep open flames, cigarettes, and sparks away from the battery area to minimise the risk of explosion. - Use only insulated jumper cables with intact insulation free from any cuts or exposed wires to prevent accidental short-circuiting. - Check that the jumper cable clamps are clean and corrosion-free to ensure a good connection and prevent sparking. 	2M

			<ul style="list-style-type: none"> - Verify that the positive and negative terminals are clearly marked and never allow them to touch each other while positioning the jumper cables. - Do not lean directly over the battery while connecting the jumper cables to avoid exposure to potential acid splashes or explosions. - Ensure that the cable connections are secure but do not apply excessive force which might damage the terminals or lead to sparking. - Stand clear of the vehicles' engines when attempting to start the working vehicle after connections are made to avoid injury from moving engine components. - In case of a suspected acid leak, neutralise spilled battery acid with baking soda or a suitable commercial acid neutraliser before proceeding. - Always have water or an emergency eyewash station nearby to rinse off any accidental acid contacts immediately. 	
3. Position Vehicles	Unintentional movement, Collision	3H	<ul style="list-style-type: none"> - Conduct pre-start check to ensure both vehicles are on flat, stable ground and set the handbrakes to prevent unintentional movement. - Ensure vehicles are parked in a designated safe area away from traffic flow to reduce collision risks. - Use wheel chocks on both vehicles to maintain stability during the jump-start process and prevent rolling. - Turn off both vehicle engines and remove the keys from ignitions to avoid accidental starts or movement. - Ensure that bystanders and workers maintain a safe distance from the vehicles while positioning them. - Clearly communicate with all team members involved before moving vehicles and use spotters if necessary to oversee safe positioning. - Engage hazard lights on both vehicles to increase visibility to others, alerting them of the ongoing process. - Avoid positioning vehicles on any incline or near flammable materials to mitigate risk in case of electrical failure. - Make sure there is sufficient space around the battery area for employees to work safely without obstruction. - Train employees on proper vehicle positioning techniques and include regular reminders about procedure safety measures in toolbox talks. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
