### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trips and falls, Struck by flying objects	2M	<ul style="list-style-type: none"> <li>- Conduct a risk assessment to identify potential hazards related to tool handling and storage before commencing work.</li> <li>- Provide training for workers on proper tool belt usage, ensuring they understand the importance of keeping tools stored and secured while working.</li> <li>- Instruct workers to inspect their tool belts regularly for wear and tear, making repairs or replacements as necessary to prevent accidental drops.</li> <li>- Equip workers with appropriate personal protective equipment such as slip-resistant footwear to minimise the chance of trips and falls.</li> <li>- Mark and maintain clear pathways at the worksite to reduce obstructions that could lead to tripping while carrying tools.</li> <li>- Use lanyards or tetherers to attach tools to the belt when working at heights, preventing them from becoming flying objects if dropped.</li> <li>- Limit the number of tools on the belt to what is necessary for the task to reduce unnecessary weight and balance.</li> <li>- Encourage workers to use both hands for stability and balance by keeping tools in the belt except when in immediate use.</li> <li>- Ensure all workers are aware of their surroundings and maintain safe distances from others when using tools to avoid incidents.</li> <li>- Provide designated areas for tool loading and unloading to organize the process and avoid mishandling during transitions.</li> <li>- Implement scheduled breaks to reduce fatigue, which can diminish attention levels and increase the risk of accidents.</li> <li>- Introduce regular safety briefings to reinforce the significance of good tool management practices, sharing any incident learnings.</li> <li>- Develop a buddy system where workers check each other's tool belts and harnesses for proper fit and integrity at regular intervals.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
