Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Poor lighting, Incorrect PPE selection	2M	<ul style="list-style-type: none"> - Ensure adequate lighting is provided in the work area, making use of natural lighting where possible and supplementing with task-specific artificial lighting if required. - Conduct a risk assessment to determine the appropriate Personal Protective Equipment (PPE) necessary for key cutting tasks. - Provide workers with clear instructions on the correct use and maintenance of PPE, including training sessions if needed. - Implement a system for regular inspection and replacement of PPE to guarantee each piece is functioning optimally and remains up-to-date with safety standards. - Encourage workers to report any discomfort or issues with PPE and promptly address concerns to maintain a safe environment. - Clearly mark designated work areas with proper signage and barricades to facilitate orderly operations and minimise confusion. - Develop and implement a Key Cutting Machine Safe Work Method Statement (SWMS) to provide a systematic approach to managing risks associated with the equipment and its operation. - Train workers in understanding and following the SWMS, emphasising the importance of complying with each outlined control measure. - Establish and enforce standard operating procedures (SOPs) for the key cutting machine to ensure consistent handling and reduction of potential hazards. - Implement routine maintenance and servicing schedules for the key cutting machine and related equipment to guarantee optimal functionality and safety. - Allocate sufficient break times for workers, encouraging regular short breaks to prevent fatigue and maintain mental alertness. - Instruct workers on the correct ergonomic posture for key cutting tasks, minimising the potential for repetitive strain injuries. - Keep the work area clean and free of debris, performing regular housekeeping tasks to maintain a tidy and safe environment. - Incorporate a dynamic risk assessment strategy that allows workers to continually assess and manage hazards as they emerge, adapting their approach to maintain a safe workplace. 	1L

			<ul style="list-style-type: none"> - Wear appropriate personal protective equipment (PPE), such as safety glasses, earmuffs and/or earplugs, to protect from flying debris and minimise exposure to high noise levels during operation. - Prioritise regular maintenance checks and servicing of the key cutting machine as per manufacturer's guidelines, to ensure it operates safely and efficiently at all times. - Keep the working area tidy and clutter-free to minimise tripping hazards and allow for unhindered access to essential equipment, including emergency stop buttons and power isolating switches. - Ensure that all employees operating the key cutting machine have received appropriate training and are aware of the relevant Workplace Health and Safety policies and procedures. - Where possible, implement engineering controls to reduce noise levels, by isolating the key cutting machine or installing sound absorbing materials in the immediate vicinity. - Only allow authorised personnel in the key cutting machine workspace, keeping unnecessary staff members away from potential hazards. - Display clear signage indicating the presence of high noise levels and electrical hazards within the work area to raise awareness among employees. - Follow a strict lockout/tagout (LOTO) procedure when performing maintenance or repairing the machine, ensuring adequate de-energisation and isolation of electrical sources. - Conduct regular risk assessments to monitor and evaluate the effectiveness of current control measures, identifying opportunities for improvements in safety precautions where necessary. - Encourage open communication among workers, promptly addressing concerns relating to the key cutting machine and ensuring all incidents are reported and adequately investigated.

- Conduct regular safety reviews: Hold periodic safety meetings to discuss potential issues, and reinforce the importance of adhering to established safety protocols to ensure a safe working environment for all employees.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
