### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Incorrect usage, Unsecured work area	3H	<ul style="list-style-type: none"> <li>- Provide comprehensive training on the proper usage of knives and cutters in an industrial setting, ensuring workers understand the risks and are aware of the precautionary measures.</li> <li>- Conduct a thorough inspection of the work area prior to commencement of work, identifying potential hazards and securing any loose objects or equipment that could pose a risk to workers.</li> <li>- Ensure all knives and cutters are sharp, in good working condition and appropriate for the task at hand. Dull blades can lead to increased force required, risk of injury or loss of control.</li> <li>- Implement a clear protocol for storing and handling knives and cutters when not in use, including designated storage areas with adequate organisational tools such as holders and racks.</li> <li>- Clearly communicate the designated work zones for tasks involving knives and cutters, maintaining appropriate distance between workers to minimise the risk of accidents.</li> <li>- Establish clear lines of communication between workers, encouraging them to report any unsafe conditions or concerns immediately.</li> <li>- Ensure that cutting tasks are performed on stable, non-slip surfaces to minimise movement and promote accurate cuts while reducing the likelihood of accidents.</li> <li>- Provide workers with suitable personal protective equipment (PPE), such as cut-resistant gloves, long-sleeve shirts, and safety goggles to mitigate potential injuries from accidents.</li> <li>- Implement a buddy system, where possible, during tasks involving the use of knives and cutters, so workers can ensure each other's safety and adherence to best practices.</li> <li>- When carrying out cutting tasks, encourage workers to keep their free hand away from the cutting edge and maintain a firm grip on the handle or tool being used.</li> <li>- Encourage regular breaks to help reduce fatigue, which may contribute to poor judgement or loss of focus, increasing the risk of accidents.</li> <li>- Review and update Safe Work Method Statements (SWMS) regularly, incorporating new learnings and addressing any identified hazards promptly.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Set up a proper storage system for blades, organising them based on their compatibility with corresponding tools and materials.</li> <li>- Prioritise using safety or self-retracting knives to minimise the risk of injury while handling and installing blades.</li> <li>- Train staff members on the correct installation procedure for various blades, as well as the importance of inspecting the condition before use.</li> <li>- Implement a tool maintenance schedule that includes regular checks and replacement of worn or damaged blades.</li> <li>- Encourage open communication within the team, providing workers with an avenue to report concerns about blade suitability, installation processes or other potential hazards related to cutting tasks.</li> </ul>

Equipment Inspection	Faulty equipment, Damaged blade	2M	<ul style="list-style-type: none"> <li>- Regularly conduct thorough visual inspections of the equipment, including checking for any signs of wear and tear or damage to components such as handles, blades, and locks.</li> <li>- Implement a preventative maintenance schedule for the knives and cutters, including routine cleaning, lubrication, and sharpening according to the manufacturer's recommendations.</li> <li>- Ensure that only qualified and trained personnel are responsible for inspecting, maintaining, and operating the industrial knives and cutters.</li> <li>- Establish a reporting system for workers to promptly communicate any concerns or issues with the equipment so they can be addressed before accidents occur.</li> <li>- Clearly label all knives and cutters with relevant safety information, warnings, and usage instructions to remind users of the potential hazards and proper handling techniques.</li> <li>- Provide appropriate personal protective equipment (PPE), such as cut-resistant gloves and safety goggles, for all workers who are required to use or handle industrial knives and cutters.</li> <li>- Store all industrial knives and cutters securely in designated areas when not in use to prevent unauthorised access and minimise the risk of accidental injury.</li> <li>- Develop comprehensive training programs for employees on the safe usage, inspection, and maintenance procedures for industrial knives and cutters - with regular refresher courses scheduled.</li> <li>- Dispose of damaged blades following proper disposal procedure ensuring compliance with environmental regulations and guidelines. Replace damaged blades promptly to avoid using faulty equipment.</li> <li>- Display posters and signage in work areas outlining the safe handling practices, correct use of PPE, and emergency response procedures relating to the use of industrial knives and cutters. Encourage a safety-conscious culture in the workplace by regularly discussing these topics during team meetings and forums.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
