Safety meetings or toolbox talks will be sched and in account with gislative requirements to first identify any site hazards, comparing those hazards and then to further take steps to either eliminate or continuous each hazard.			
If an incident or a near miss occurs, all work must sto, quately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Select a ladder with a suitable height so that you can reach your work area without overreaching or standing on the top rungs. Position the ladder on a stable, flat surface to prevent wobbling or tipping during use. Extend the ladder three rungs above the point of support when accessing an elevated platform or roof for superior stability. Ensure there is a minimum distance of one metre between the ladder and any overhead hazards such as power lines. Maintain a 4:1 ratio while setting up the ladder (for every four metres in height, the base should be one metre out from the wall). Verify the ladder is securely locked in its open position, and all spreader bars are fully extended and engaged. Use non-slip safety shoes to reduce the risk of slipping while ascending or descending the ladder. Designate a spotter if possible to hold the base of the ladder steady during critical tasks. Keep the area around the ladder clear of tools, materials, and debris to provide unobstructed access. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised.
